### 1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Chimney stacks	Visually inspected with the aid of binoculars where appropriate.  The chimney stacks are of brick construction externally roughcast and served with metal flashings.

#### Roofing including roof space

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

The roof is of pitched timber construction externally tiled incorporating tiled ridging and hips. Our inspection of the roof covering was restricted by the solar panels.

The upper level is incorporated within the roof structure and accordingly no access was gained to any roof timbers. Access to the apex of the roof space is via two hatches within the upper floor landing and access to the eaves area is via two hatches within the master bedroom. It should be appreciated that only a restricted head and shoulders inspection was carried out of these areas and only the roof timbers around the hatches could beclosely inspected. A further hatch was noted within the utility room although no access was gained to this area due to the location of a cupboard unit.

## Garages and permanent outbuildings

Visually inspected.

There is a detached double garage (31m²) with attached cinema room (26m²). The cinema room has been lined internally and has electric installed. The ceiling has been lowered and insulation has been installed at rafter level. There is an additional larger garage/workshop (77m²). The structures are of concrete block and stone construction externally roughcast with pitched and tiled roofs.

A former outbuilding has been converted to create an annexe/holiday let accommodation (as previously detailed - 62m²). This is of similar construction to the above outbuildings and has been timber framed and insulated internally. This is self-contained accommodation with an wet electric heating system and separate electric motor supported septic tank system. Access is via upvc double glazed patio doors and there are uPVC double glazed and velux window units. Fittings throughout are modern. No access was gained to the roof void.

#### **Outside areas and boundaries**

Visually inspected.

There are amenity grounds surrounding the main building and a private drive to allow for off-street parking. Separate access is available to the annexe/holiday let building and this has a courtyard area. The property is also understood to have ownership over a small forested area at the entrance to the site.

Boundaries comprise hedging, timber fencing and there are concrete block and stone retaining walls within the garden to the west of the property. There is a water course running at lower level adjacent to the site.

#### **Ceilings**

Visually inspected from floor level.

The ceilings appear to be of plasterboard design.

#### Internal walls

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

The internal walls are of timber stud overlaid in plasterboard.

## Surfaces of exposed floors were visually inspected. No carpets or floor Floors including sub floors coverings were lifted. Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so, and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch. The flooring is of suspended timber and chipboard construction. Due to fully fitted floor coverings no detailed inspection was possible of the flooring and accordingly, we cannot comment on its soundness or otherwise. No sub floor inspection was carried out. Internal joinery and kitchen Built-in cupboards were looked into but no stored items were moved. fittings Kitchen units were visually inspected excluding appliances. The internal doors, skirtings and architraves are of timber design. The kitchen and utility room comprise a range of units in modern styling. A timber staircase adjoins ground to first floor level. Chimney breasts and fireplaces Visually inspected. No testing of the flues or fittings was carried out. There is an open fire within the dining room and a wood burning stove in the lounge. Internal decorations Visually inspected. Internal surfaces are papered and painted and there are areas clad in

#### **Electricity**

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Mains supply. The meter and consumer unit are located within the kitchen cupboard.

Solar panels have been installed on the south facing roof pitch and we understand there is an associated feed-in tariff. Further information in this regard should be obtained.

#### Gas

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Private supply. The LPG tank is located externally.

## Water, plumbing, bathroom fittings

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Mains supply. There is a sink unit within the kitchen and utility room and where viewed, the plumbing system is of PVC and copper design.

The sanitary fittings within the property are modern. The bathroom comprises a toilet, washhand basin and bath with plumbed-in shower over whilst the en-suite comprises a toilet, wash and basin and shower enclosure with plumbed-in shower over.

#### Heating and hot water

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

Space heating is by means of an LPG gas fired system. There is a Worcester Greenstar condensing combination boiler located within a kitchen cabinet and this serves wall-mounted radiators within the main apartments. There is electric underfloor heating within the bathroom. The central heating system appears to provide domestic hot water.

#### **Drainage**

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

There are two septic tanks on site, one for the main building and a modern motor supported system for the annexe/holiday let. These were not inspected.

#### Fire, smoke and burglar alarms

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

Smoke and burglar alarms are provided within the property.

#### **Additional limits to inspection**


It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

The property was fully furnished at the time of our inspection and the services were not tested.

Notes	There is evidence of settlement in the building noted both internally and externally but this is not inconsistent with a property of this age and type and on the basis of a single inspection appears to be longstanding.

Notes	There are historic wood boring holes within the roof timbers and floor timbers within the master bedroom cupboard. We have been informed that this was treated in the past and damp proofing works have also been carried out. A check should be made for any relevant reports or guarantees in this regard. If none are available or guarantees have lapsed then an updated inspection is recommended in order to renew guarantees.

Notes  East Gallowfauld Farm Forfar DD8	We noted no significant defects to the chimney stacks from our ground level inspection. Ongoing maintenance should be expected, particularly to the flashing details in order to ensure watertightness.  Page 11 of 27



## **Roofing including roof space**

Repair category	1
Notes	The roof covering is in fair condition having been renewed in the past. Further information should be sought in this regard if available in order to provide better information as to the age and expected lifespan of the tiles. The tiles are typically weathered and slightly moss covered. Roof coverings of this type and age require regular and ongoing maintenance and an annual inspection is recommended.



## Rainwater fittings

Notes	At the time of our inspection there was no evidence of damp staining/water
	staining on wall surfaces which would indicate leakage.



## Main walls

Repair category	2
Notes	The main outer walls of the property generally appeared in fair order consistent with age. There is some bossed roughcast.



## Windows, external doors and joinery

Repair category	2

Notes	The windows are of mixed age, with a selection of units having been replaced in recent years. Some units are of an age now where ongoing maintenance will be required to ensure they are kept in satisfactory condition, particularly timber based velux units. Interstitial condensation was noted to a lounge unit.
	Double glazed windows may be prone to misting/interstitial condensation which can be more evident and can change in certain temperatures/weather conditions.
	Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/repair will be required as part of an ongoing maintenance programme.



## **External decorations**

Repair category	1
Notes	The external decoration appears to have been refreshed in recent years.  These areas will require regular repainting in order to be maintained in a satisfactory condition.



## **Conservatories / porches**

Repair category	2
Notes	The conservatory is generally in a condition consistent with age although interstitial condensation was noted to have formed between a number of the window panes and there is some wear to seals and PVC trims.



## **Communal areas**

Notes	The access road is potholed in areas. Maintenance liabilities should be verified.



## **Garages and permanent outbuildings**

Repair category	2
Notes	The outbuildings are of mixed age and condition. The annexe/holiday let cottage has been fully renovated in renovated in recent years and appeared in good order. The cinema room has also been refurbished although retains older windows. The doors of both garages were operational during our inspection.  Typical age related defects were noted to more traditional elements, including weathering to the roof coverings cracking to the walls of the larger garage. We understand that a downpipe to the larger garage is to be reinstated prior to
	sale and guttering is to be fixed.



## **Outside areas and boundaries**

Notes	The outside areas were found to be generally well maintained and boundaries were intact during our inspection.
	The forest is understood to pertain to the subjects and incorporates mature trees requiring monitoring/maintenance.
	There is a water course adjacent although not understood to fall within the maintenance of the property.

Notes	Within the limits of our inspection these generally appeared in fair condition consistent with age. During redecoration some plaster filling/repair may be required.  The ceiling height is limited in areas at upper level.

Notes	Within the limits of our inspection these generally appeared in fair condition consistent with age. During redecoration some plaster filling/repair may be required.



## Floors including sub-floors

Notes	There is a run in the flooring timbers at upper floor level due to past internal movement.

Notes	We noted no significant defects to the internal joinery or kitchen fittings.  Previous modernisation has been carried out.

## **Chimney breasts and fireplaces**

Notes	We understand that chimney flues have recently been attended to. Documentation should be sought.  It is assumed that the wood/multi fuel apparatus has been installed in accordance with the manufacturer's recommendations in particular regard to flueing and ventilation. The appliance was not tested.



## **Internal decorations**

Notes	The property was well presented during our inspection.



## **Cellars**

Notes	Not applicable.



## **Electricity**

Repair category	1
Notes	The consumer unit has been upgraded in the past although it is unclear the extent of upgrading works having been carried out to concealed wiring. Any information as to past re-wiring works should be obtained, if available. It should be appreciated that only the most recently installed or re-wired properties comply with current regulations and as in all cases, we recommend that the system be checked prior to purchase by an NICEIC/Select registered electrical contractor.  The Institution of Engineering and Technology recommends that inspections and testing are undertaken at least every ten years and on a change of ownership. It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.

Notes	In the interest of safety all gas appliances should be checked by a Gas Safe registered engineer.

Notes	The plumbing and fittings appear of copper/PVC piping where seen and appeared in serviceable condition but was not tested.  The sanitary fittings are of modern style and type. Waterproof seals were intact at the time of our inspection. No high moisture levels or suspect flooring were noted to the limited accessible areas surrounding.	



## Heating and hot water

Notes	The central heating boiler has been upgraded in the past to a condensing type although it should be appreciated that boilers have a limited life only and a copy of relevant installation/servicing documentation should be obtained in order to better advise on its current condition and expected lifespan. Radiators and pipework is mixed and some future upgrading should be expected.



## Drainage

Notes	Drainage, we understand is to two exclusive septic tank which we understand lies within the feu. These were not checked or tested. It should be ensured that appropriate registration documents are available. The systems are assumed to have been suitably maintained throughout their history.

### 4. Valuation and conveyance issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

#### Matters for a solicitor or licensed conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that when repairs, defects or maintenance items have been identified interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

Drainage, we understand is to two exclusive septic tank which we understand lies within the feu. These were not checked or tested. It should be ensured that appropriate registration documents are available. The systems are assumed to have been suitably maintained throughout their history.

The subjects are accessed via a shared unmade farm track. It is assumed that a right of access exists and any repairing liability in this regard should be confirmed.

It is has been previously understood that the access track that divides the east most section of ground from the main garden does not form part of the subjects although we understand the there is a right of access over this. This should be verified.

There is a water course at lower level to the south of the site. We are unaware of any history of flooding having affected the subjects.

The former outbuilding has been converted to an annexe/holiday let cottage. It is assumed that all building warrants are in order for this.

The subjects have been altered and extended in the past and the valuation assumes that all consents and permissions are available and in order.

### Estimated reinstatement cost for insurance purposes

£700.000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £700,000 (Seven Hundred Thousand Pounds Sterling).

#### Valuation and market comments

#### £500,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £500,000 (Five Hundred Thousand Pounds Sterling).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

#### TERMS AND CONDITIONS OF SINGLE SURVEY

**GENERAL** 

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. \*

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box. Yes

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

#### 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Report may give rise to a conflict of interest and if this is of concern to any party they are advised to seek their own independent advice.

The Report and any expressions or assessments in it are not intended as advice to the Seller or Purchaser or any other person in relation to an asking price or any other sales or marketing decisions.

The Report is based solely on the Property and is not to be relied upon in any manner whatsoever when considering the valuation or condition of any other property.

If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

#### 2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

#### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Report of Property that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

#### 2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

#### 2.3.1 Category 3:

Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the Property or cause a safety hazard. Estimates for repairs or replacement are needed now.

Repairs or replacement requiring future attention, but estimates are still advised.

#### 2.3.3 Category 1:

No immediate action or repair is needed.

#### WARNING:





#### The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. #### The impact of your home on the environment



#### About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

#### 1 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide long-lasting weather protection. Further information can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

#### 2 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

#### 3 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

#### 4 Wind turbine

A wind turbine provides electricity from wind energy. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Wind turbines are not suitable for all properties. The system's effectiveness depends on local wind speeds and the presence of nearby obstructions, and a site survey should be undertaken by an accredited installer. Planning permission might be required and building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for a wind turbine, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). #### Low and zero carbon energy sources
