1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Weather	Sunny and dry

Chimney stacks	Visually inspected with the aid of binoculars where appropriate.
	The chimney stacks are of ornate stonework served with metal and cement flashings, where viewed. A limited inspection was possible from ground level.

Roofing including roof space	Sloping roofs were visually inspected with the aid of binoculars where appropriate.
	Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.
	Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.
	The roof is of pitched timber construction externally clad in slate with zinc ridging, hips and valleys. There are flat coverings over the vestibule and bay projection and there is also a flat platform area around the rooflight which could not be viewed. Access to the roof space is via a hatch within the shower room area. This hatch gives access to a lowered ceiling area with the main hatch at a higher level. Due to the location of the hatch, a very restricted inspection of the roof timbers was possible. It was noted that the roof space has been insulated and insulation is laid over joists. This severely restricted our inspection.
Rainwater fittings	Visually inspected with the aid of binoculars where appropriate.
	The rainwater goods are of cast iron and PVC design.

Main walls	Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.
	The main walls are of solid stone construction with rendered and painted window margins at points. An ornate balustrade is provided over the side vestibule.

Windows, external doors and joinery	Internal and external doors were opened and closed where keys were available.
	Random windows were opened and closed where possible.
	Doors and windows were not forced open.
	The windows are of double glazed timber sash, single glazed timber sash and single glazed timber sash with secondary glazing. Windows are stained glass at ground floor level within the hallway and vestibule areas.
	Access to the property is via the original timber panelled entry doors.

External decorations	Visually inspected.

Conservatories / porches	Not applicable.

Communal areas	Not applicable.

Garages and permanent	Visually inspected.
outbuildings	There is a single garage with workshop area which is semi-detached and lies to the rear of the property, accessed from Shaftesbury Road. This is of stone and brick construction with a slate roof while the workshop area appears timber framed and timber clad with a flat felt roof over.

Outside areas and boundaries	Visually inspected.
	The subjects are served with a corner site enclosed with hedging and stone retaining walls. Off-street parking is provided to the rear and there is a cobbled courtyard area to the side and rear.

Ceilings	Visually inspected from floor level.
	The ceilings are of timber lath and plaster throughout with a papered or painted finish. Ornate features are provided within the main apartments. Lowered plasterboard ceilings have been formed at points within.

Internal walls	Visually inspected from floor level.
	Using a moisture meter, walls were randomly tested for dampness where considered appropriate.
	The internal walls are of brick construction plastered on the hard, timber lath and plaster and timber stud overlaid in plasterboard. Internal surfaces are papered and painted and there are areas of tiling within the kitchen, utility room and sanitary areas.

Floors including sub floors	Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.
	Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.
	The flooring within is of suspended timber construction and also solid concrete and suspended concrete which is tiled. Due to fitted carpets and floor coverings no detailed inspection was possible of the floor timbers and accordingly we cannot comment on their soundness or otherwise. No sub-floor inspection was possible as no hatch could be located.

Internal joinery and kitchen	Built-in cupboards were looked into but no stored items were moved.
fittings	Kitchen units were visually inspected excluding appliances.
	The internal doors are of original timber panelled and timber and glazed design.
	The kitchen units are serviceable and older units are provided within the utility room.
	A stone stair adjoins ground to upper floor level.

Chimney breasts and fireplaces	Visually inspected. No testing of the flues or fittings was carried out.
	Marble fireplaces are provided within the lounge, main bedroom and mid bedroom and these are served with living flame gas fires. Any other fireplaces have been removed/blocked and we presume adequately vented.

	or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.
	It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.
	Mains supply of water. There is a sink unit within the kitchen and Belfast sinks are provided within the utility room. Fittings within the cloakroom and bathroom areas are on traditional lines and modern fittings are provided within the shower room area. No view was possible of any cold water tank.

Heating and hot water	Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.
	Space heating is by means of a full gas fired system and the radiators are served with mixed piping and partial individual thermostats. There is a Viessmann regular boiler within the side porch and this is served with a fan assisted flue. The central heating system provides domestic hot water along with an electrical immersion heater. There is a large insulated hot water cylinder within the utility room area.

Drainage	Drainage covers etc were not lifted.
	Neither drains nor drainage systems were tested.
	Presumed to be connected to the main public sewer.

Fire, smoke and burglar alarms	Visually inspected.
	No tests whatsoever were carried out to the system or appliances.
	New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

Notes	Movement has affected the property observed in the form of cracking to lintels and sills externally while internally there is a slight run in the flooring timbers and some plaster cracking has occurred. Historic repairs have been carried out at points. On the basis of a single inspection this appears to be longstanding and non-progressive.
	Dampness, rot and infestation

Notes	A check should be made to ascertain if any timber specialist repair works have been carried out within the property in the past and all reports and guarantees should be obtained, studied and authenticated prior to purchase. Staining was noted within the roof space and higher than average damp readings were obtained within the utility room area, and also within the wine cellar area although it is noted that some damp proof membrane repairs have been carried out within this area. As a precautionary measure it is
	recommended that a timber specialist firm is instructed prior to purchase to carry out a full inspection of the property.

4. Valuation and conveyance issues

TERMS AND CONDITIONS OF SINGLE SURVEY

GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Report of Property that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a materialaffect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

2.3.1 Category 3:

Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the Property or cause a safety hazard. Estimates for repairs or replacement are needed now.

2.3.2 Category 2:

Repairs or replacement requiring future attention, but estimates are still advised.

2.3.3 Category 1:

No immediate action or repair is needed.



The energy efficiency rating of your home

About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

1 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide longlasting weather protection. Further information can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

2 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

3 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

4 Double glazed windows

Double glazing is the term given to a system where two panes of glass are made up into a sealed unit. Replacing existing single-glazed windows with double-glazed windows will improve comfort in the home by reducing draughts and cold spots near windows. Double-glazed windows may also reduce noise, improve security and combat problems with condensation. Building regulations apply to this work and planning permission may also be required, so it is best to check with your local authority on what standards need to be met. A building warrant is not required if the windows comply with the current requirements.

5 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

Low and zero carbon energy sources
