## 1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

<b>Neighbourhood and Location</b>	The subjects form part of a long established residential location approximately one mile north of Dundee City centre. The surrounding properties are predominantly of a similar age and character. Baxter Park is located opposite the property and Morgan Academy is located within the immediate vicinity. All amenities are available within easy reach.

<b>Chimney Stacks</b>	<p>Visually inspected with the aid of binoculars where appropriate.</p> <p>The chimney stacks appear to be of stone construction with the chimney stack over the rear outshoot having a rendered finish. Where viewed, the flashings are of a cement fillet design.</p>
<b>Roofing including Roof Space</b>	<p>Sloping roofs were visually inspected with the aid of binoculars where appropriate.</p> <p>Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.</p> <p>The roof is of pitched timber construction externally laid in slate, incorporating metal ridging.</p> <p>Access to the main roof space is via a hatch and fitted ladder within the first floor landing. This area has been floored, lined and divided to create two separate attic rooms. Accordingly no access was gained to any roof timbers within this area. Access to the roof timbers over the rear outshoot is via a hatch within the kitchen and this area is partially floored and insulated at rafter level.</p>
<b>Rainwater Fittings</b>	<p>Visually inspected with the aid of binoculars where appropriate.</p> <p>The rainwater fittings are of cast iron and PVC design and the roof structure incorporates valley gutters lined with metal sheeting.</p>
<b>Main Walls</b>	<p>Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.</p> <p>The main walls are of solid stone construction and the rear vestibule appears to be of brick construction externally rendered and painted.</p>

<b>Windows, External Doors and Joinery</b>	<p>Internal and external doors were opened and closed where keys were available.</p> <p>Random windows were opened and closed where possible.</p> <p>Doors and windows were not forced open.</p> <p>The windows are of coated aluminium and timber double glazed design.</p> <p>Access to the property is via a timber and glazed front door and there are uPVC double glazed French doors to the rear.</p>
<b>External Decorations</b>	Visually inspected.
<b>Conservatories / Porches</b>	Not applicable.
<b>Communal Areas</b>	Not applicable.
<b>Garages and Permanent Outbuildings</b>	<p>Visually inspected.</p> <p>There is a detached double garage of brick/block construction externally roughcast with a pitched and tiled roof over. The inspection of the garage was restricted due to contents.</p>
<b>Outside Areas and Boundaries</b>	<p>Visually inspected.</p> <p>The garden is mainly laid out to the front although there is also a small courtyard style area to the rear of the property. The boundaries comprise a mixture of stone, brick and concrete block walls and metal railings.</p>
<b>Ceilings</b>	<p>Visually inspected from floor level.</p> <p>The ceilings are of timber lath and plaster and plasterboard type with a papered and painted finish. There are ornate and plain corning features within the property. The ceilings within the bathroom and shower room are clad in timber panelling and the kitchen and rear vestibule ceilings are clad in decorative panelling.</p>

<b>Internal Walls</b>	<p>Visually inspected from floor level.</p> <p>Using a moisture meter, walls were randomly tested for dampness where considered appropriate.</p> <p>Internal walls are of timber lath and plaster and timber stud overlaid in plasterboard construction. Internal surfaces are papered and painted and there are areas clad in tiles.</p>
<b>Floors Including Sub-Floors</b>	<p>Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.</p> <p>Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so, and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.</p> <p>The flooring is of solid concrete and suspended timber construction. The floors are fully covered and no sub-floor inspection was carried out.</p>
<b>Internal Joinery and Kitchen Fittings</b>	<p>Built-in cupboards were looked into but no stored items were moved.</p> <p>Kitchen units were visually inspected excluding appliances.</p> <p>The internal doors are of timber panel and timber/glazed design.</p> <p>The kitchen comprises wall and base units in a modern style.</p> <p>A timber staircase adjoins ground to first floor level.</p>
<b>Chimney Breasts and Fireplaces</b>	<p>Visually inspected. No testing of the flues or fittings was carried out.</p> <p>There is a gas fire within the lounge and a former fireplace within the ground floor bedroom.</p>
<b>Internal Decorations</b>	Visually inspected.
<b>Cellars</b>	Not applicable.

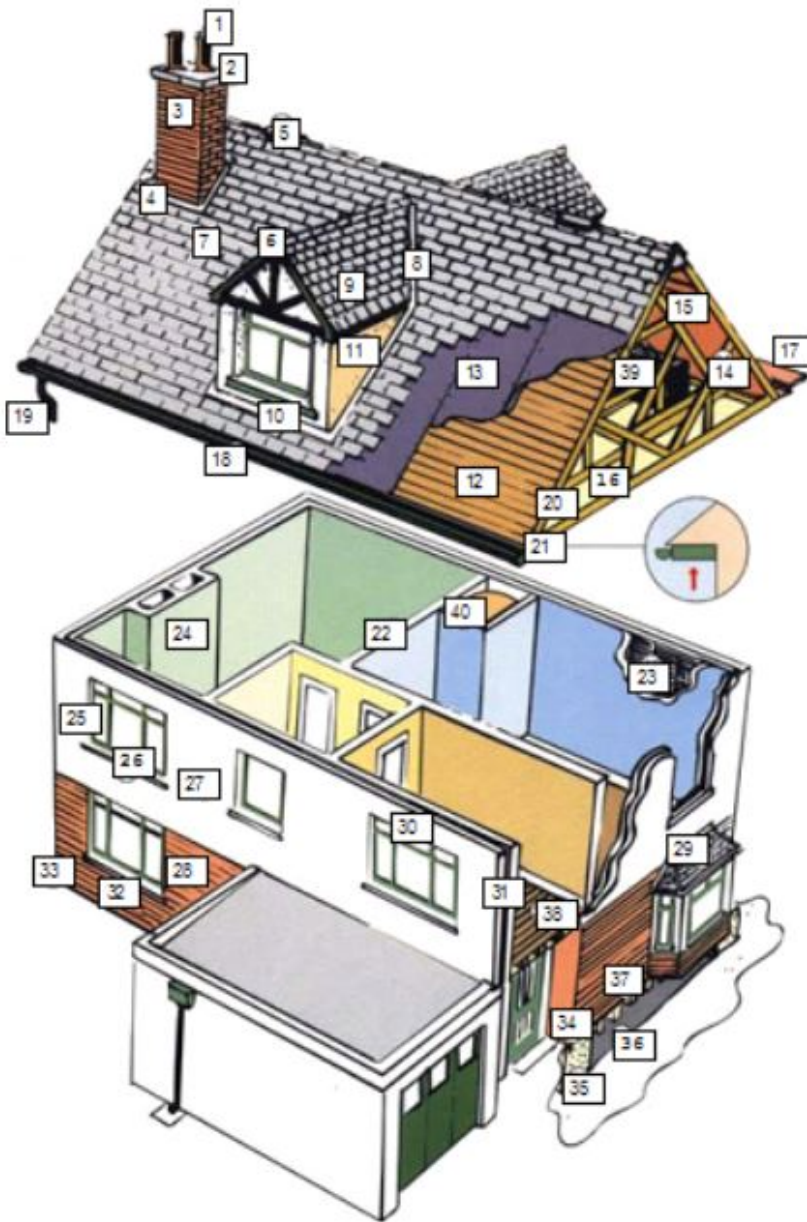
<b>Electricity</b>	<p>Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>Mains supply. The meter and fusebox are boxed-in within the bathroom.</p>
<b>Gas</b>	<p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>Mains supply.</p>
<b>Water, Plumbing and Bathroom Fittings</b>	<p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.</p> <p>Mains supply. There is a stainless steel sink unit within the kitchen and, where viewed, the plumbing system is of PVC and copper design.</p> <p>The sanitary fittings are of a mixed age and there are plumbed-in shower systems within the bathroom and shower room.</p>

<b>Heating and Hot Water</b>	<p>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.</p> <p>Space heating is by means of a gas fired system. There is a Worcester Greenstar condensing conventional boiler and modern insulated hot water cylinder located within the roof void over the kitchen. The boiler serves wall mounted radiators and also appears to provide domestic hot water.</p>
<b>Drainage</b>	<p>Drainage covers etc were not lifted.</p> <p>Neither drains nor drainage systems were tested.</p> <p>Mains sewer connection.</p>
<b>Fire, Smoke and Burglar Alarms</b>	<p>Visually inspected.</p> <p>No tests whatsoever were carried out to the system or appliances.</p> <p>New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.</p> <p>Smoke and fire alarms were noted.</p>



<p><b>Additional limits to Inspection</b></p>	<p>It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.</p> <p>No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.</p> <p>It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.</p>

<b>Notes</b>	<p>There is evidence of settlement in the building noted both internally and externally but this is not inconsistent with a property of this age and type and on the basis of a single inspection appears to be longstanding.</p> <p>A structural support known as a bearer bar was noted to the ground floor bedroom window opening externally. This appears to have been installed historically although a check should be made for any available reports or documentation.</p>


 Dampness, Rot and Infestation	
<b>Repair Category</b>	<b>1</b>
<b>Notes</b>	<p>There was no evidence found of significant dampness, rot or infestation within those areas of the property available for inspection.</p> <p>Timber and damp specialist repairs may have been carried out within the property in the past and a check should be made for any relevant reports or guarantees.</p>


 Chimney Stacks	
<b>Repair Category</b>	<b>2</b>

Notes	The chimney stacks are weathered and there are a number of open mortar joints which will require repointing. The rendered chimney stack is cracked and there is some evidence of vegetation growth. Repairs should be expected. It should be appreciated that these are of an age where ongoing maintenance will be required, particularly to the flashing details to ensure watertightness.

	<b>Roofing including Roof Space</b>
<b>Repair Category</b>	2
Notes	The roof covering is original and a number of slipped and broken slates were noted.  The roof covering is now of an age where ongoing and regular maintenance will be required and it would be prudent to seek the advice of a roofing contractor to comment on its current condition and expected lifespan.

	<b>Rainwater Fittings</b>
<b>Repair Category</b>	2
Notes	The cast iron fittings are rusting. The system is of a mixed age and elements will require above average maintenance.

	<b>Main Walls</b>
<b>Repair Category</b>	2
Notes	The stonework is weathered and scaling and there are a number of open mortar joints particularly to the gable elevation.  Cracking was noted to a number of lintels and sills as a result of past movement. On the basis of our single inspection the movement appears longstanding and non-progressive. As per structural movement, a bearer bar was noted.

	<b>Windows, External Doors and Joinery</b>

<b>Repair Category</b>	2
Notes	<p>The windows and doors are generally of an older style. The front door is slightly ill-fitting and the French door frame is damaged.</p> <p>Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/repair will be required as part of an ongoing maintenance programme.</p> <p>Double glazed windows may be prone to misting/interstitial condensation which can be more evident and can change in certain temperatures/weather conditions.</p> <p>Decay was noted to the timber fascia board on the gable elevation.</p>

	<b>Outside Areas and Boundaries</b>
<b>Repair Category</b>	2
Notes	The boundaries are well defined and generally adequately maintained. Traditional stone walls require ongoing maintenance and monitoring. You should verify with your conveyancer the extent of the boundaries attaching to the property.


	<b>Ceilings</b>
<b>Repair Category</b>	1
Notes	<p>Historic cracking noted. The ceilings are of lath and plaster construction and the strength of this type of ceiling depends on how well the plaster keys into the lath.</p> <p>Historic staining was noted to the ceiling within the rear bedroom at first floor level. This area appeared dry at the time of our inspection.</p>

	<b>Internal Walls</b>
<b>Repair Category</b>	1
Notes	The internal walls are largely covered with decorative finishes. During routine redecoration some plaster filling may be necessary.

	<b>Floors including Sub-Floors</b>
<b>Repair Category</b>	1
Notes	There is a run in the flooring appearing to be as a result of previous movement. On the basis of a single inspection this appears longstanding and non-progressive.

	<b>Internal Joinery and Kitchen Fittings</b>
<b>Repair Category</b>	1
<b>Notes</b>	The internal joinery and kitchen fittings are affected by typical wear and tear. There are distorted door surrounds as a result of past internal movement.


	<b>Chimney Breasts and Fireplaces</b>
<b>Repair Category</b>	1
<b>Notes</b>	All flue linings should be checked, repaired if necessary and swept prior to the fires being reused.  The gas fire was not tested. A copy of servicing history documentation should be obtained prior to purchase. This is assumed to be in order.


	<b>Internal Decorations</b>
<b>Repair Category</b>	1
<b>Notes</b>	The property is adequately presented.


	<b>Cellars</b>
<b>Repair Category</b>	-
<b>Notes</b>	Not applicable.

	<b>Electricity</b>
<b>Repair Category</b>	2


Notes	<p>The electrical installation is dated and as such we recommend that it be checked and upgraded as necessary by an NICEIC registered Electrical Contractor.</p> <p>The Institution of Engineering and Technology recommends that inspections and testing are undertaken at least every ten years and on a change of occupancy. It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.</p>

<b>Repair Category</b>	<b>1</b>
Notes	In the interest of safety all gas appliances should be checked by a Gas Safe Registered Engineer.

	<b>Water, Plumbing and Bathroom Fittings</b>
<b>Repair Category</b>	<b>1</b>
Notes	<p>The plumbing and fittings appear of copper/PVC piping where seen and appeared in serviceable condition but was not tested.</p> <p>The sanitary fittings appeared in fair order consistent with age.</p> <p>Waterproof seals were generally intact at the time of our inspection. No high moisture levels or suspect flooring were noted to the limited accessible areas surrounding.</p>

	<b>Heating and Hot Water</b>
<b>Repair Category</b>	<b>2</b>
Notes	<p>The central heating boiler and hot water cylinder are reasonably modern although the radiators and associated pipework are mainly dated. Further upgrading should be anticipated.</p> <p>The central heating system is assumed to have been suitably serviced throughout its history and a copy of relevant documentation in this regard should be obtained prior to purchase. This is assumed to be in order.</p>

Notes	The property is thought to be connected to a main sewer. There was no surface evidence to suggest the system is choked or leaking.

## 4. Valuation and Conveyance Issues

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

There is no evidence of any recent alterations.

You should verify with your conveyancer the extent of the boundaries attaching to the property.

### Estimated Reinstatement Cost for Insurance Purposes

£570,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than **£570,000** (Five Hundred and Seventy Thousand Pounds Sterling).

### Valuation and Market Comments

£270,000

Market Value assuming vacant possession is **£270,000** (Two Hundred and Seventy Thousand Pounds Sterling).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

## TERMS AND CONDITIONS OF SINGLE SURVEY

### GENERAL

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. \*

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box.

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

\* Which shall be in accordance with the current RICS Appraisal and Valuation Standards (The Red Book) and RICS Rules of Conduct.

#### 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Report may give rise to a conflict of interest and if this is of concern to any party they are advised to seek their own independent advice.

The Report and any expressions or assessments in it are not intended as advice to the Seller or Purchaser or any other person in relation to an asking price or any other sales or marketing decisions.

The Report is based solely on the Property and is not to be relied upon in any manner whatsoever when considering the valuation or condition of any other property.

If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

#### 1.3 Liability

The Report is prepared with the skill and care reasonably to be expected of a competent residential surveyor who is a member of the Royal Institution of Chartered Surveyors.

The Report is addressed to the Seller and is prepared in the expectation that it (or a complete copy) along with these Terms and Conditions (or a complete copy) would be (or, as the case might be, would have been) disclosed and delivered to:

- the Seller;
- any person(s) noting an interest in purchasing the Property from the Seller;
- any person(s) who make(s) (or on whose behalf is made) an offer to purchase the Property, whether or not that offer is accepted by the Seller;
- the Purchaser; and
- the professional advisors of any of these.

The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

Graham + Sibbald's total liability to the Client (and any third party relying upon this report) under this Agreement (including liability in contract, tort (including negligence), breach of statutory duty, or otherwise) shall be limited to the lower of the following : a) 25% of the valuation or b) £250,000.

### 1.4 Generic Mortgage Valuation Report

The Surveyors undertake to the Seller that they will prepare a Generic Mortgage Valuation Report, which will be issued along with the Report. It is the responsibility of the Seller to ensure that the Generic Mortgage Valuation Report is provided to every potential Purchaser.

### 1.7 Payment

The Surveyors are entitled to refrain from delivering the Report to anyone until the fee and other charges for it notified to the Seller have been paid. Additional fees will be charged for subsequent inspections and Reports, including replacement home reports.

### 1.8 Cancellation

The Seller will be entitled to cancel the inspection by notifying the Surveyor's office at any time before the day of the inspection.

The Surveyor will be entitled not to proceed with the inspection (and will so report promptly to the Seller) if after arriving at the Property, the Surveyor concludes that it is of a type of construction of which the Surveyor has insufficient specialist knowledge to be able to provide the inspection satisfactorily. - the "Transcript Mortgage Valuation Report for Lending Purposes" means a separate report, prepared by the Surveyor, prepared from information in the Report and the generic Mortgage Valuation Report, but in a style and format required by the Lender. ### DESCRIPTION OF THE REPORT

#### 2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

#### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, **visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.**

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Report of Property that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

#### 2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

##### 2.3.1 Category 3:

Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the Property or cause a safety hazard. Estimates for repairs or replacement are needed now.

##### 2.3.2 Category 2:

Repairs or replacement requiring future attention, but estimates are still advised.

##### 2.3.3 Category 1:

No immediate action or repair is needed.

#### WARNING:

If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. The existence of Category 2 or Category 3 repairs may have an adverse effect on marketability, value and the sale price ultimately achieved for the Property. ## 2.6 Energy Report

A section is included that makes provision for an Energy Report, relative to the Property. The Surveyor will collect physical data from the Property and provide such data in a format required by an accredited energy company. The Surveyor cannot of course accept liability for any advice given by the energy company.

## 2.7 Valuation & Conveyancer Issues

The last section of the Report contains matters considered relevant to the conveyancer (solicitor). It also contains the Surveyor's opinion both of the market value of the Property and of the re-instatement cost, as defined below.

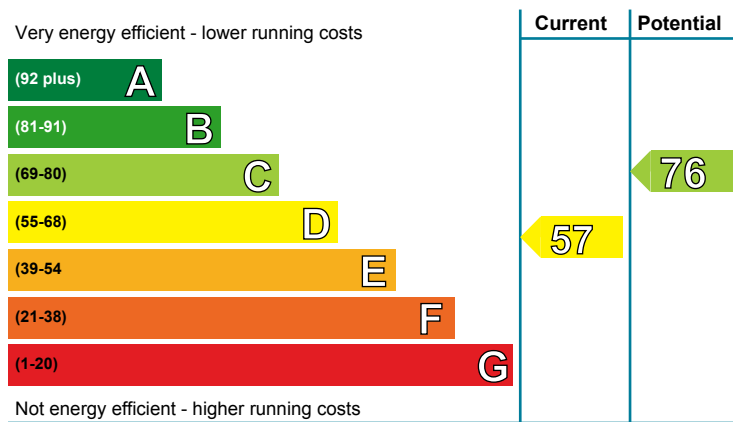

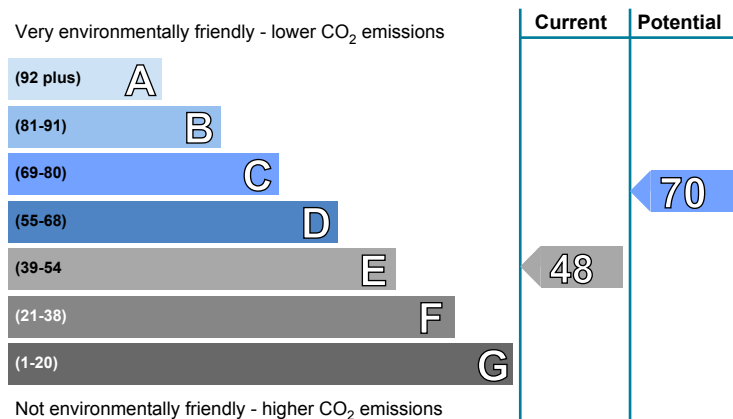


## Energy Efficiency Rating

## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO<sub>2</sub> emissions, running costs and the savings possible from making improvements.


## The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 57 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 7.6 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 3.2 tonnes per year. You could reduce emissions even more by switching to renewable energy sources.












## About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

### 1 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide long-lasting weather protection. Further information can be obtained from the National Insulation Association ([www.nationalinsulationassociation.org.uk](http://www.nationalinsulationassociation.org.uk)). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

### 2 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including [www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation](http://www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation). Building regulations generally apply to this work so it is best to check with your local authority building standards department.

### 3 Hot water cylinder insulation

Increasing the thickness of existing insulation around the hot water cylinder will help to maintain the water at the required temperature; this will reduce the amount of energy used and lower fuel bills. An additional cylinder jacket or other suitable insulation layer can be used. The insulation should be fitted over any thermostat clamped to the cylinder. Hot water pipes from the hot water cylinder should also be insulated, using pre-formed pipe insulation of up to 50 mm thickness, or to suit the space available, for as far as they can be accessed to reduce losses in summer. All these materials can be purchased from DIY stores and installed by a competent DIY enthusiast.

### 4 Low energy lighting

Replacement of traditional light bulbs with energy saving bulbs will reduce lighting costs over the lifetime of the bulb, and they last many times longer than ordinary light bulbs. Low energy lamps and fittings are now commonplace and readily available. Information on energy efficiency lighting can be found from a wide range of organisations, including the Energy Saving Trust (<http://www.energysavingtrust.org.uk/home-energy-efficiency/lighting>).

### 5 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at [www.microgenerationcertification.org](http://www.microgenerationcertification.org).

### 6 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). ## Low and zero carbon energy sources
