## 1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

<b>Neighbourhood and Location</b>	The subjects form part of an established residential location within the West End of Dundee, approximately two miles West of the City Centre and within easy reach of Ninewells Hospital. The surrounding properties are predominantly of a similar age and character and all amenities are available within easy reach.

<b>Chimney Stacks</b>	<p>Visually inspected with the aid of binoculars where appropriate.</p> <p>There is a mutual chimney stack of brick construction externally roughcast and served with metal flashing details.</p>
<b>Roofing including Roof Space</b>	<p>Sloping roofs were visually inspected with the aid of binoculars where appropriate.</p> <p>Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.</p> <p>Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.</p> <p>The main roof is of pitched timber construction externally clad in tiles and served with tiled ridging. The roofs over the breakfast room and side vestibule are flat and overlaid in mineral felt whilst the roof over the sun room is of a shallow pitched type laid in lightweight Decra tiles.</p> <p>Access to the roof void is via a hatch and fitted ladder within the landing. The roof void has been floored and lined to create an attic room and accordingly this restricted our inspection of the roof timbers. Where viewed insulation was noted.</p>
<b>Rainwater Fittings</b>	<p>Visually inspected with the aid of binoculars where appropriate.</p> <p>The rainwater fittings are of cast iron and PVC design and the roof structure incorporates valley gutters lined with metal sheeting.</p>
<b>Main Walls</b>	<p>Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.</p> <p>The main walls appear to be of solid and cavity brick construction externally roughcast. The side vestibule area appears to be of timber frame construction externally roughcast.</p>

<b>Windows, External Doors and Joinery</b>	<p>Internal and external doors were opened and closed where keys were available.</p> <p>Random windows were opened and closed where possible.</p> <p>Doors and windows were not forced open.</p> <p>The property features a combination of uPVC double and triple glazed windows, as well as aluminium double glazed windows.</p> <p>Access to the property is via a composite and glazed front door and there are uPVC and double glazed French doors within the sun room providing access to rear garden.</p>
<b>External Decorations</b>	Visually inspected.
<b>Conservatories / Porches</b>	Not applicable.
<b>Communal Areas</b>	Not applicable.
<b>Garages and Permanent Outbuildings</b>	<p>Visually inspected.</p> <p>There is a detached double garage of concrete block and roughcast construction with a flat felt roof over. A lean-to style shed is attached to the garage.</p>
<b>Outside Areas and Boundaries</b>	<p>Visually inspected.</p> <p>There are areas of garden laid out to the front, side and rear of the property and off-street parking is provided within the driveway. The boundaries comprise traditional stone and brick walls which are partially of a retaining style and the rear garden incorporates low-level brick walls.</p>
<b>Ceilings</b>	<p>Visually inspected from floor level.</p> <p>The ceilings are a combination of timber lath and plaster, plasterboard and lightweight boarding with a papered and painted finish. The ceiling within the dining room is clad in timber panelling whilst the ceilings within the kitchen and breakfast room are clad in decorative panelling.</p>

<b>Internal Walls</b>	<p>Visually inspected from floor level.</p> <p>Using a moisture meter, walls were randomly tested for dampness where considered appropriate.</p> <p>The internal walls are a combination of brick construction plastered on the hard, timber lath and plaster and timber stud overlaid in plasterboard. Internal surfaces are papered and painted and there are areas clad in tiles and decorative panelling.</p>
<b>Floors Including Sub-Floors</b>	<p>Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.</p> <p>Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.</p> <p>Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.</p> <p>The flooring is of solid concrete and suspended timber construction. The floors are fully covered and no sub-floor inspection was carried out.</p>
<b>Internal Joinery and Kitchen Fittings</b>	<p>Built-in cupboards were looked into but no stored items were moved.</p> <p>Kitchen units were visually inspected excluding appliances.</p> <p>The internal doors are of timber panel and timber/glazed design.</p> <p>The kitchen comprises a range of units in a modern style.</p> <p>A timber staircase adjoins ground to first floor level.</p>
<b>Chimney Breasts and Fireplaces</b>	<p>Visually inspected. No testing of the flues or fittings was carried out.</p> <p>Any original open fireplaces have been removed. There is an electric fire within the lounge and a gas fire within the dining room which has been disconnected.</p>

<b>Electricity</b>	<p>Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>Mains supply. The meter and consumer unit are located within a cabinet in the ground floor study.</p>

<b>Gas</b>	<p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>Mains supply. The meter is located externally.</p>

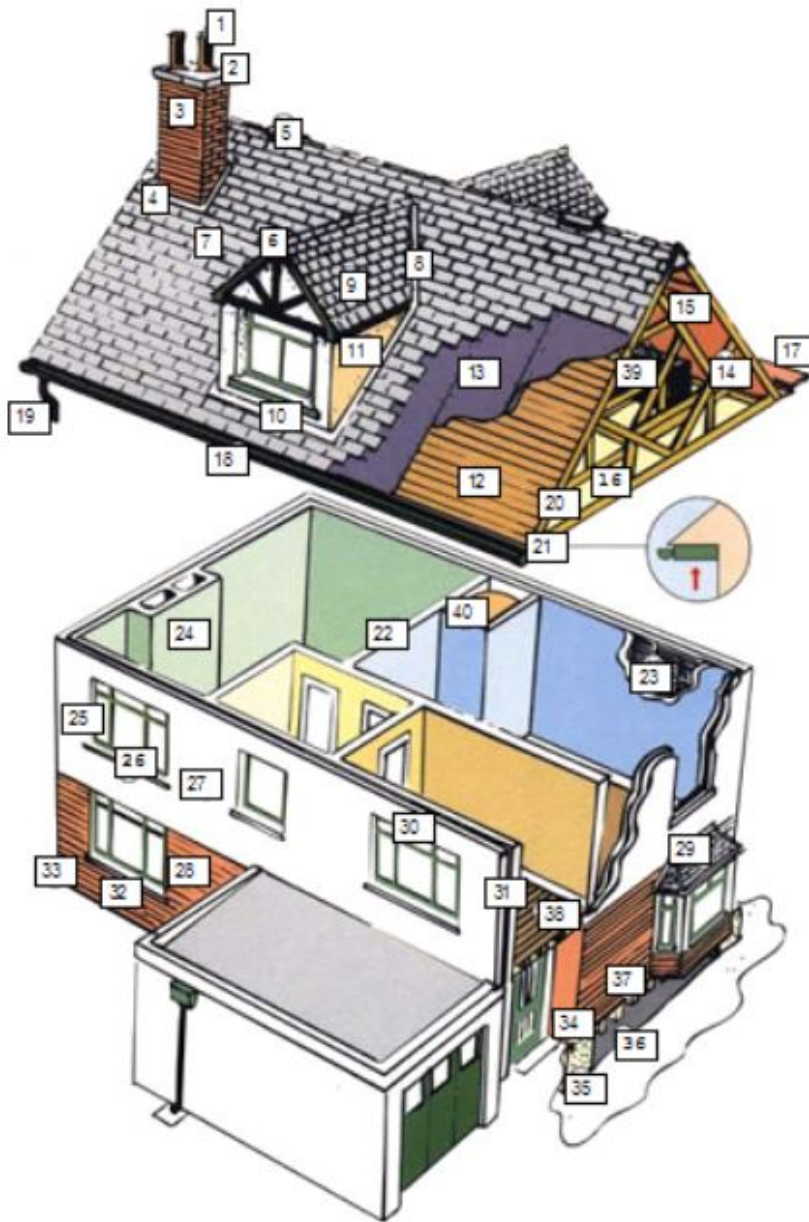
<b>Water, Plumbing and Bathroom Fittings</b>	<p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.</p> <p>Mains supply. There is a ceramic sink unit within the kitchen and, where viewed, the plumbing system is of PVC and copper design.</p> <p>The bathroom fittings comprise a toilet, two wash hand basins, bidet, bath and separate shower enclosure with plumbed-in shower over. The cloakroom fittings comprise a toilet and wash hand basin.</p>

<b>Heating and Hot Water</b>	<p>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.</p> <p>Space heating is by means of a gas fired system. There is a Worcester Greenstar condensing combination boiler located within the understair cupboard and this feeds wall mounted radiators and towel rails. The central heating system provides domestic hot water.</p>
<b>Drainage</b>	<p>Drainage covers etc were not lifted.</p> <p>Neither drains nor drainage systems were tested.</p> <p>Mains sewer connection.</p>
<b>Fire, Smoke and Burglar Alarms</b>	<p>Visually inspected.</p> <p>No tests whatsoever were carried out to the system or appliances.</p> <p>New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.</p> <p>Smoke and fire alarms were noted.</p>



<b>Additional limits to Inspection</b>	<p>It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.</p> <p>No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.</p> <p>It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.</p>

<b>Notes</b>	There is a run in the flooring timbers, noticeable at first floor level, and this appears to be as a result of past internal movement. On the basis of our superficial single inspection this appears longstanding and non-progressive.


 Dampness, Rot and Infestation	
<b>Repair Category</b>	<b>1</b>
<b>Notes</b>	There was no evidence found of significant dampness, rot or infestation within those areas of the property available for inspection.


 Chimney Stacks	
<b>Repair Category</b>	<b>2</b>
<b>Notes</b>	The chimney stack appears to be original and typical weathering has occurred to the roughcast and the cementwork appears cracked. It should be appreciated that this is of an age where ongoing mutual maintenance will be required, particularly to the flashing details to ensure watertightness.


	<b>Roofing including Roof Space</b>
<b>Repair Category</b>	<b>1</b>
Notes	The main roof was renewed circa five years ago and a check should be made for any available reports or guarantees in this regard. Where viewed the flat felt roof coverings appear worn. It should be appreciated that flat roofs have a limited life only and any information as to its last renewal date should be obtained if available.


	<b>Rainwater Fittings</b>
<b>Repair Category</b>	<b>1</b>
Notes	At the time of our inspection there was no evidence of damp staining/water staining on wall surfaces which would indicate leakage. It should be noted that it was not raining at the time of our inspection.


	<b>Main Walls</b>
<b>Repair Category</b>	<b>1</b>
Notes	The main outer walls of the property generally appeared in fair order consistent with age.


	<b>Windows, External Doors and Joinery</b>
<b>Repair Category</b>	<b>1</b>
Notes	<p>The windows are of a mixed age/style. Where tested, these were generally found to function adequately, although a few windows were noted to be slightly stiff and may require to be adjusted.</p> <p>Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/repair will be required as part of an ongoing maintenance programme.</p> <p>Double glazed windows may be prone to misting/interstitial condensation which can be more evident and can change in certain temperatures/weather conditions.</p>

	<b>External Decorations</b>
<b>Repair Category</b>	1
Notes	The external decorations are generally in adequate order. Regular repainting will be required if these areas are to be maintained in satisfactory condition.


	<b>Conservatories / Porches</b>

Notes	Not applicable.

	<b>Garages and Permanent Outbuildings</b>
<b>Repair Category</b>	1
Notes	The garage and lean-to are in a condition consistent with age and construction type. Felt roofs have a limited life only and require ongoing maintenance.


	<b>Outside Areas and Boundaries</b>
<b>Repair Category</b>	2

Notes	The boundaries are well defined and generally in a condition consistent with age and construction type. The stone retaining wall along the front of the site is affected by historic movement, reflected in the form of a lean. The traditional stone walls enclosing the rear garden are weathered and there are a number of open mortar joints which would benefit from repointing. The low-level brick wall within the rear garden is leaning as a result of past movement. You should verify with your conveyancer the extent of the boundaries attaching to the property.

<b>Repair Category</b>	<b>1</b>
Notes	Cracked plasterwork noted. The ceilings are mainly of lath and plaster construction and the strength of this type of ceiling depends on how well the plaster keys into the lath.


	<b>Internal Walls</b>
<b>Repair Category</b>	<b>1</b>
Notes	The internal walls are largely covered with decorative finishes. During routine redecoration some plaster filling may be necessary.

	<b>Floors including Sub-Floors</b>
<b>Repair Category</b>	<b>1</b>
Notes	There is a run in the flooring timbers, noticeable at first floor level, and this appears to be as a result of past internal movement. On the basis of our superficial single inspection this appears longstanding and non-progressive.


	<b>Internal Joinery and Kitchen Fittings</b>

Notes	The internal joinery is mainly on original lines whilst the kitchen fittings have been upgraded. While some typical wear and tear is visible, no significant defects were observed.

Notes	All original fireplaces have been removed/blocked and we assume adequately vented.

Notes	The property is well presented.

	<b>Electricity</b>
Repair Category	2
Notes	<p>The electrical installation appears to incorporate mixed age elements with parts of the system being dated. As such, the system should be checked and upgraded as necessary by an NICEIC/Select registered contractor.</p> <p>The Institution of Engineering and Technology recommends that inspections and testing are undertaken at least every ten years and on a change of occupancy. It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.</p>

	<b>Gas</b>
<b>Repair Category</b>	1
Notes	In the interest of safety all gas appliances should be checked by a Gas Safe registered engineer.

	<b>Water, Plumbing and Bathroom Fittings</b>
<b>Repair Category</b>	1
Notes	<p>The plumbing and fittings appear of copper/PVC piping where seen and appeared in serviceable condition but was not tested.</p> <p>The sanitary fittings are in a condition consistent with age and type. Waterproof seals were generally intact at the time of our inspection. No high moisture levels or suspect flooring were noted to the limited accessible areas surrounding.</p>

	<b>Heating and Hot Water</b>
<b>Repair Category</b>	2
Notes	<p>While the central heating boiler has been upgraded to a more efficient condensing model, the radiators are of an older design. It is anticipated that further upgrades to the heating system, specifically the radiators, will be required in the future.</p> <p>The central heating system is assumed to have been suitably serviced throughout its history and a copy of relevant documentation in this regard should be obtained prior to purchase. This is assumed to be in order.</p>

Notes	The property is thought to be connected to a main sewer. There was no surface evidence to suggest the system is choked or leaking.

Restricted parking includes parking that is subject to parking restrictions, as indicated by the presence of solid yellow, red or white lines at the edge of the road or by a parking control sign, parking meters or other coin-operated machines.

## 4. Valuation and Conveyance Issues

### Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

The subjects have been altered and extended in the past although these works appear to have been carried out in excess of 20 years ago and are therefore considered to be historic.

### Estimated Reinstatement Cost for Insurance Purposes

£570,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £570,000 (Five Hundred and Seventy Thousand Pounds Sterling).

### Valuation and Market Comments

£385,000

Market Value assuming vacant possession is £385,000 (Three Hundred and Eighty Five Thousand Pounds Sterling).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

## TERMS AND CONDITIONS OF SINGLE SURVEY

### GENERAL

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. \*

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box.

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

#### 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

#### 1.3 Liability

The Report is prepared with the skill and care reasonably to be expected of a competent residential surveyor who is a member of the Royal Institution of Chartered Surveyors.

The Report is addressed to the Seller and is prepared in the expectation that it (or a complete copy) along with these Terms and Conditions (or a complete copy) would be (or, as the case might be, would have been) disclosed and delivered to:

- the Seller;
- any person(s) noting an interest in purchasing the Property from the Seller;
- any person(s) who make(s) (or on whose behalf is made) an offer to purchase the Property, whether or not that offer is accepted by the Seller;
- the Purchaser; and
- the professional advisors of any of these.

The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

### 1.8 Cancellation

The Seller will be entitled to cancel the inspection by notifying the Surveyor's office at any time before the day of the inspection.

### DESCRIPTION OF THE REPORT

#### 2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

#### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, **visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.**

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

#### 2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

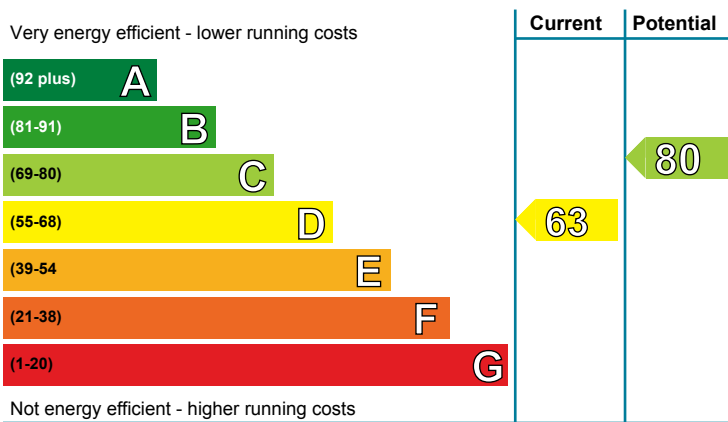

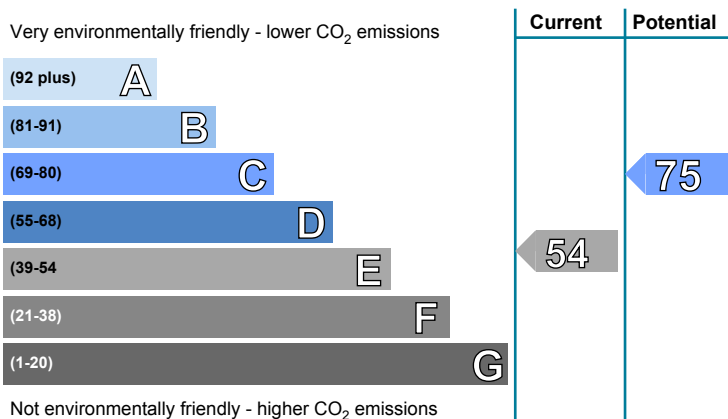

## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. ## The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 49 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 8.4 tonnes of carbon dioxide every year. 

## About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

### 1 Flat roof or sloping ceiling insulation

Insulating a flat roof or sloping ceiling will significantly reduce heat loss through the roof; this will improve levels of comfort, reduce energy use and lower fuel bills. Insulation can be placed on top of the roof under the waterproof membrane and should particularly be considered when the waterproofing needs to be replaced. Further information about roof insulation and details of local contractors can be obtained from the National Insulation Association ([www.nationalinsulationassociation.org.uk](http://www.nationalinsulationassociation.org.uk)). Building regulations generally apply to this work so it is best to check with your local authority building standards department.

### 2 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide long-lasting weather protection. Further information can be obtained from the National Insulation Association ([www.nationalinsulationassociation.org.uk](http://www.nationalinsulationassociation.org.uk)). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

### 3 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including [www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation](http://www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation). Building regulations generally apply to this work so it is best to check with your local authority building standards department.

### 4 Low energy lighting

Replacement of traditional light bulbs with energy saving bulbs will reduce lighting costs over the lifetime of the bulb, and they last many times longer than ordinary light bulbs. Low energy lamps and fittings are now commonplace and readily available. Information on energy efficiency lighting can be found from a wide range of organisations, including the Energy Saving Trust (<http://www.energysavingtrust.org.uk/home-energy-efficiency/lighting>).

### 5 Heating controls (room thermostat)

The heating system should have a room thermostat to enable the boiler to switch off when no heat is required. A competent heating engineer should be asked to do this work. Insist that the thermostat switches off the boiler as well as the pump and that the thermostatic radiator valve is removed from any radiator in the same room as the thermostat. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

### 6 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent).
