## 1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

<b>Accommodation</b>	<p>Ground Floor - Entrance Hallway.</p> <p>Lower Ground Floor - Hallway, Cinema Room, Bedroom with En-Suite Shower Room and walk-in cupboard, Utility Room and Cloakroom WC.</p> <p>First Floor - Hallway, Open Plan Living Kitchen, Lounge, Bedroom, Bathroom with separate shower and WC.</p> <p>Attic Floor - Landing, 2 Bedrooms with En-Suite Shower Rooms.</p>

<b>Neighbourhood and Location</b>	The subjects form part of an established location on the periphery of Montrose town centre. The surrounding properties are of a mixed type and all amenities are available within easy reach. The property benefits from views to the rear over the Montrose Basin.

<b>Weather</b>	Dry.
<b>Chimney Stacks</b>	<p>Visually inspected with the aid of binoculars where appropriate.</p> <p>The chimney stacks are of brick and stone construction and incorporate metal flashing details.</p>
<b>Roofing including Roof Space</b>	<p>Sloping roofs were visually inspected with the aid of binoculars where appropriate.</p> <p>Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.</p> <p>The roof is of pitched timber construction, externally laid in slate and incorporates a large flat platform which appears to be overlaid in a continuous membrane type material. The roof covering over the single storey outshoot is flat and laid in a continuous membrane type material.</p> <p>No access was gained to any roof timbers at the time of our inspection.</p>
<b>Rainwater Fittings</b>	<p>Visually inspected with the aid of binoculars where appropriate.</p> <p>The rainwater fittings are of PVC design. The front elevation incorporates a parapet gutter laid in metal sheeting.</p>
<b>Main Walls</b>	<p>Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.</p> <p>The main walls are of solid stone construction, internally lined. The rear extension is of timber frame construction externally clad in decorative panelling.</p>

<b>Windows, External Doors and Joinery</b>	<p>Internal and external doors were opened and closed where keys were available.</p> <p>Random windows were opened and closed where possible.</p> <p>Doors and windows were not forced open.</p> <p>The windows are of uPVC and Velux double glazed design.</p> <p>Access to the property is via a composite panelled front door and composite and glazed rear door.</p>
<b>External Decorations</b>	Visually inspected.
<b>Conservatories / Porches</b>	Not applicable.
<b>Communal Areas</b>	Not applicable.
<b>Garages and Permanent Outbuildings</b>	<p>Visually inspected.</p> <p>Outbuildings comprise a Garden Room which is of timber and felt construction.</p>
<b>Outside Areas and Boundaries</b>	<p>Visually inspected.</p> <p>The property abuts the pavement to the front, whilst to the rear there is a adequate area of garden that is split level. This area incorporates a composite deck, paved patio and lawn and is enclosed with traditional stone walls.</p>
<b>Ceilings</b>	<p>Visually inspected from floor level.</p> <p>The ceilings appear to be clad in plasterboard throughout the property and these have a painted finish. These are partially coombed at attic floor level.</p>

<b>Internal Walls</b>	<p>Visually inspected from floor level.</p> <p>Using a moisture meter, walls were randomly tested for dampness where considered appropriate.</p> <p>The internal walls are of masonry construction lined with plasterboard and timber stud overlaid in plasterboard. Internal surfaces are painted and there are areas clad in tiles and decorative panelling. There is a facing stone and brick wall within the hallway at lower ground floor level.</p>
<b>Floors Including Sub-Floors</b>	<p>Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.</p> <p>The flooring is of solid concrete and suspended timber construction. The floors were fully covered and no access was gained into any sub-floor areas.</p>
<b>Internal Joinery and Kitchen Fittings</b>	<p>Built-in cupboards were looked into but no stored items were moved.</p> <p>Kitchen units were visually inspected excluding appliances.</p> <p>The internal doors are of timber panel and timber/glazed design.</p> <p>The kitchen comprises a range of units and incorporates an island and quartz worktops. The utility room comprises a base unit in a modern style.</p> <p>The staircases are of timber and stone construction.</p>
<b>Chimney Breasts and Fireplaces</b>	<p>Visually inspected. No testing of the flues or fittings was carried out.</p> <p>Any original fireplaces have been removed.</p>
<b>Internal Decorations</b>	Visually inspected.
<b>Cellars</b>	Not applicable.

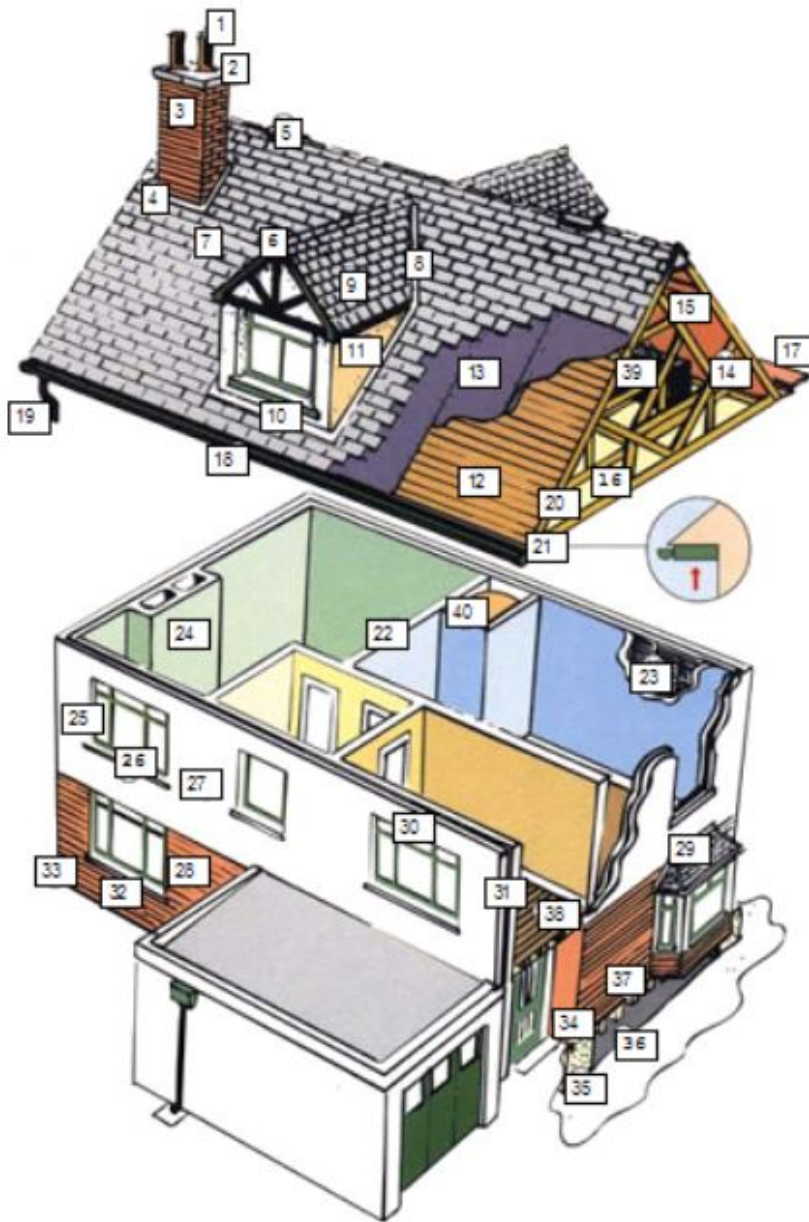
<b>Electricity</b>	<p>Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>Mains supply. There is a meter and consumer unit located within the cabinet on the stairs leading to the lower ground floor level and there is a secondary consumer unit within the cupboard at attic floor level</p>
<b>Gas</b>	<p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>Mains supply.</p>
<b>Water, Plumbing and Bathroom Fittings</b>	<p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.</p> <p>Mains supply. There are sink units within the kitchen and utility room and, where viewed, the plumbing system is of PVC and copper design.</p> <p>The sanitary fittings are modern and the shower enclosures all incorporate plumbed in shower systems.</p>

<b>Heating and Hot Water</b>	<p>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.</p> <p>Space heating is by means of a gas fired system. There is a modern Ideal Logic condensing conventional boiler and modern insulated hot water cylinder within the landing cupboard at attic floor level. The boiler serves wall mounted radiators and also provides domestic hot water backed up by the electrical immersion heater system.</p>
<b>Drainage</b>	<p>Drainage covers etc were not lifted.</p> <p>Neither drains nor drainage systems were tested.</p> <p>Mains sewer connection.</p>
<b>Fire, Smoke and Burglar Alarms</b>	<p>Visually inspected.</p> <p>No tests whatsoever were carried out to the system or appliances.</p> <p>New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.</p> <p>Smoke and fire alarms were noted.</p>



<b>Additional limits to Inspection</b>	<p>It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.</p> <p>No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.</p> <p>It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.</p>

<b>Notes</b>	There is evidence of settlement internally which has occurred following the refurbishment and was noted in the form of hairline plaster cracking and a couple of slightly ill-fitting doors. This is not inconsistent with a property of this age and type and on the basis of a single inspection appears to be longstanding.


 Dampness, Rot and Infestation	
<b>Repair Category</b>	<b>1</b>
<b>Notes</b>	There was no evidence found of significant dampness, rot or infestation within those areas of the property available for inspection.  Timber and damp specialist repairs may have been carried out as part of the refurbishment and a check should be made for any available documentation.

 Chimney Stacks	
<b>Repair Category</b>	<b>2</b>
<b>Notes</b>	The chimney stacks are weathered consistent with age and there are open mortar joints evident which would benefit from repointing. It should be appreciated that they are of an age where ongoing maintenance will be required, particularly to flashing details to ensure watertightness.


	<b>Roofing including Roof Space</b>
<b>Repair Category</b>	2
Notes	<p>The roof covering over the property is assumed to have been overhauled at the time of refurbishment, although the slaterwork appears to be along original lines. However, the large flat platform appears to have been renewed.</p> <p>It should be appreciated that the roof coverings of this type and age require ongoing maintenance and an annual inspection is recommended.</p>


	<b>Rainwater Fittings</b>
<b>Repair Category</b>	1
Notes	<p>At the time of our inspection there was no evidence of damp staining/water staining on wall surfaces which would indicate leakage. It should be noted that it was not raining at the time of our inspection.</p> <p>The parapet gutter should be checked and maintained on a regular basis as gutters of this type can be a source of water ingress and resultant defects.</p>


	<b>Main Walls</b>
<b>Repair Category</b>	1
Notes	The main walls have been stone cleaned and repointed in the past.


	<b>Windows, External Doors and Joinery</b>
<b>Repair Category</b>	1


Notes	<p>The windows and doors are modern and where tested, function adequately.</p> <p>Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/repair will be required as part of an ongoing maintenance programme.</p> <p>Double glazed windows may be prone to misting/interstitial condensation which can be more evident and can change in certain temperatures/weather conditions.</p>

Notes	<p>The plumbing and fittings appear of copper/pvc piping where seen and appeared in serviceable condition but were not tested.</p> <p>The sanitary fittings are of modern style and type.</p> <p>Waterproof seals were generally intact at the time of our inspection. No high moisture levels or suspect flooring were noted to the limited accessible areas surrounding.</p>

Notes	<p>The central heating system is modern.</p> <p>The central heating system is assumed to have been suitably serviced throughout its history and a copy of relevant documentation in this regard should be obtained prior to purchase. This is assumed to be in order.</p>

## 4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

### Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

We understand the subjects were fully refurbished internally and extended at lower ground floor level in around 2021. It is assumed that all necessary and relevant Local Authority consents and permissions were obtained. All available documentation in this regard should be obtained.

### Estimated Reinstatement Cost for Insurance Purposes

£1,100,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £1,100,000 (One Million One Hundred Thousand Pounds Sterling).

### Valuation and Market Comments

£335,000

Market Value assuming vacant possession is £335,000 (Three Hundred and Thirty Five Thousand Pounds Sterling).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

## TERMS AND CONDITIONS OF SINGLE SURVEY

### GENERAL

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. \*

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box.  Yes

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

\* Which shall be in accordance with the current RICS Appraisal and Valuation Standards (The Red Book) and RICS Rules of Conduct.

#### 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

#### 1.3 Liability

The Report is prepared with the skill and care reasonably to be expected of a competent residential surveyor who is a member of the Royal Institution of Chartered Surveyors.

The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

#### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, **visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.**

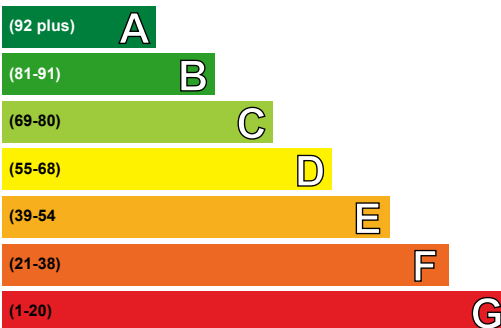

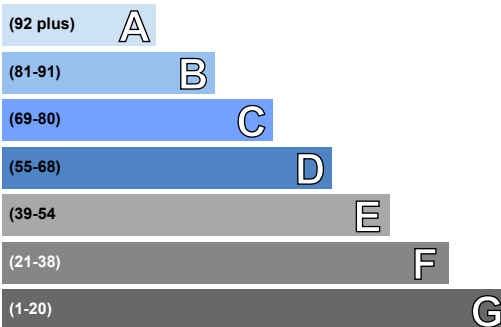

## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. ## The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 26 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 7.4 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 1.3 tonnes per year. 

### 1 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). ### 2 Solar photovoltaic (PV) panels
