1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	The subjects comprise a Category 'B' Listed villa with accommodation across three levels, with the upper two being partially formed within the roof structure.

Neighbourhood and location	The subjects are located on the eastern periphery of Dundee within a long established area. Surrounding properties are of a mixed residential type and Craigiebarns Primary School is located directly to the rear of the subjects. All amenities are available within easy reach.

Chimney stacks	Visually inspected with the aid of binoculars where appropriate. The chimney stacks are of brick construction, partially roughcast and served with metal flashings.

Roofing including roof space	<p>Sloping roofs were visually inspected with the aid of binoculars where appropriate.</p> <p>Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.</p> <p>The roof is of pitched timber construction, with a steep sloping pitch. The structure is externally laid in slate incorporating tiled ridging. There are slate clad dormer projections incorporated within the roof structure.</p> <p>Access to the apex of the roof space is via a hatch within the rearmost attic floor bedroom and this has a drop down ladder installed. Additional access is via eaves hatches at this level. We noted joist level insulation but only in part, with remaining areas found to have no insulation present.</p>

Rainwater fittings	Visually inspected with the aid of binoculars where appropriate. The rainwater fittings are of aluminium, cast iron and pvc design. Valley gutters which are laid in metal sheeting are incorporated within the roof structure.

Main walls	<p>Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.</p> <p>The main walls would appear to be of solid brick construction, externally roughcast incorporating facing stonework features. The walls have a whitewashed finish.</p>
Windows, external doors and joinery	<p>Internal and external doors were opened and closed where keys were available.</p> <p>Random windows were opened and closed where possible.</p> <p>Doors and windows were not forced open.</p> <p>The windows are of original single glazed timber casement design with partial secondary glazing.</p> <p>Access to the property is via timber and glazed and timber panel entrance doors.</p>
External decorations	<p>Visually inspected.</p> <p>Elements of the external fabric have a painted finish.</p>
Conservatories / porches	<p>Visually inspected.</p> <p>There is a sun room area integral to the main structure incorporating large profile single glazing.</p>

Garages and permanent outbuildings	<p>Visually inspected.</p> <p>There is a detached tandem garage of timber and mineral felt construction. Outbuildings comprise a brick and felt store, an attached boiler room, a brick and felt bin store and a brick and slate BBQ hut.</p>

Outside areas and boundaries	<p>Visually inspected.</p> <p>The subjects are set within a site of approximately 0.67 acres, bounded by timber fencing, brick walls (finished with roughcast) and a stone/rubble wall. Off-street parking is provided for multiple vehicles on a private drive.</p>

Ceilings	<p>Visually inspected from floor level.</p> <p>The ceilings are of timber lath and plaster and plasterboard type with a papered and painted finish. There are coombed sections.</p>

Internal walls	<p>Visually inspected from floor level.</p> <p>Using a moisture meter, walls were randomly tested for dampness where considered appropriate.</p> <p>The internal walls are of brick construction plastered on the hard, timber lath and plaster and timber stud overlaid in plasterboard. Internal surfaces are papered and painted and there are areas clad in tiles and timber panelling.</p>

Floors including sub floors	<p>Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.</p> <p>Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.</p> <p>The flooring is of suspended timber construction and solid construction. Due to fully fitted floor coverings no detailed inspection was possible of the flooring and accordingly we cannot comment on its soundness or otherwise. No sub-floor inspection was carried out as no access hatch could be located.</p>

Internal joinery and kitchen fittings	<p>Built-in cupboards were looked into but no stored items were moved.</p> <p>Kitchen units were visually inspected excluding appliances.</p> <p>The internal doors are of timber panel, timber flush panel and timber/glazed design.</p> <p>The kitchen and utility room comprise wall and base units in a reasonably modern style.</p> <p>There are timber staircases within the property. There are various fitted cupboards and wardrobes available.</p>
Chimney breasts and fireplaces	<p>Visually inspected. No testing of the flues or fittings was carried out.</p> <p>There are open fireplaces within the lounge and dining room and a wood burning stove within the kitchen.</p>
Internal decorations	<p>Visually inspected.</p> <p>Papered/painted and tiled finishes.</p>
Cellars	<p>N/A</p>
Electricity	<p>Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>Mains supply of electricity with 13 amp power outlets in the various apartments. There is a meter and consumer unit within the cloakroom understair cupboard and a further consumer unit within the eastmost bedroom cupboard at first floor level.</p>

Gas	<p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>Mains supply.</p>

Water, plumbing, bathroom fittings	<p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>Mains supply. There is a stainless steel sink unit within the kitchen and utility room. Where viewed, the plumbing system is of pvc and copper design.</p> <p>The sanitary fittings in the property are of a mixed age/style. Plumbed-in electric shower systems are provided.</p> <p>There is a pvc cold water tank within the roof space.</p>

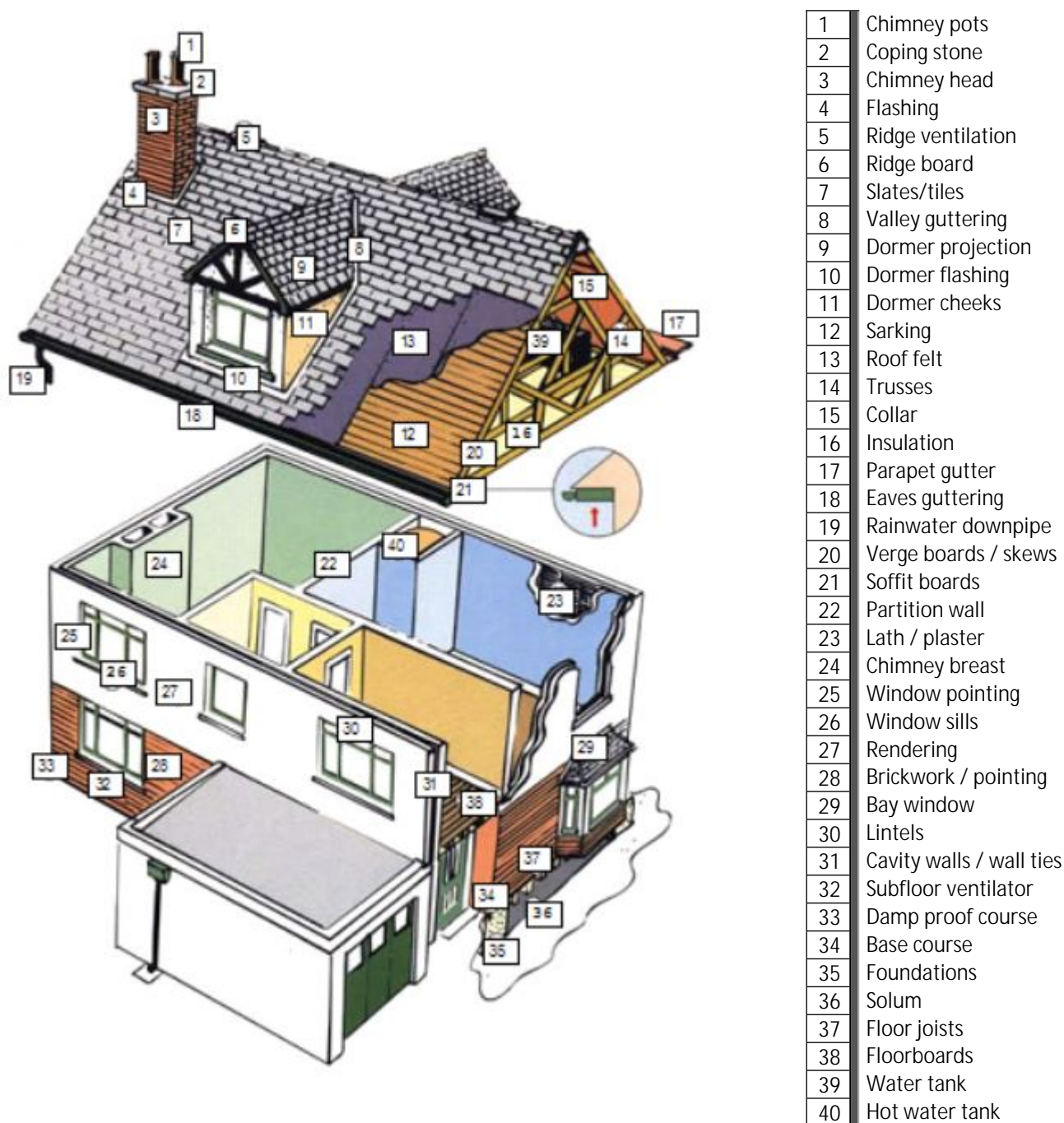
Heating and hot water	<p>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.</p> <p>Space heating is by means of a gas fired system. There is a Potterton conventional boiler floorstanding within the attached boiler room and this serves wall mounted radiators within the main apartments.</p> <p>There is a insulated hot water cylinder within the utility room cupboard and this is served with an electrical immersion heater. It is assumed that the central heating system provides the domestic hot water.</p>

Drainage	<p>Drainage covers etc were not lifted.</p> <p>Neither drains nor drainage systems were tested.</p> <p>Drainage is to the mains sewer.</p>

Fire, smoke and burglar alarms	<p>Visually inspected.</p> <p>No tests whatsoever were carried out to the system or appliances.</p> <p>New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.</p>

Additional limits to inspection	<p>The property was fully furnished at the time of our inspection and the services were not tested.</p> <p>It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.</p> <p>No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.</p> <p>It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.</p>



Notes	There is evidence of settlement in the building noted both internally and externally but this is not inconsistent with a property of this age and type and on the basis of a single inspection appears to be longstanding.

Notes	There was no evidence found of significant dampness, rot or infestation within those areas of the property available for inspection. In a property of this age and type it is possible that there may be structural defects which are presently concealed by floor coverings, plasterwork, etc.	
	Chimney stacks

Notes	The chimney stacks are in fair condition consistent with age. Previous patching and recent repainting have been carried out although any potential purchaser should expect to implement a continued maintenance programme, including to the chimney flashings to ensure watertightness. Salt staining was noted to the brickwork of the visible stack within the roof space.

Notes	<p>The roof covering over the subjects appears original although previous roofing repair works have been carried out, including timber replacement. Chipped and weathered slates were noted and there is staining to roof timbers, with accessible parts found to be dry (although not all could be reached for testing). Insulation is missing in parts.</p> <p>This is a large profile roof, incorporating junctions and valleys and accordingly will require a considered maintenance programme to ensure it is kept in satisfactory condition. It would be prudent to seek the advice of a roofing contractor to comment on its current condition and expected lifespan.</p>

Notes	<p>We noted no leakages to the system although it will require to be checked during a period of heavy rainfall. We understand that the system is regularly cleared and this is a practice that should be continued due to the proximity of trees within the site. There are older cast iron installations and these will require ongoing maintenance.</p>

Notes	<p>The main outer walls of the property generally appeared in fair order consistent with age. General weathering was noted to the roughcast and facing stonework although we noted no significant issues requiring urgent attention.</p>

Notes	<p>The windows serving the property are original, with some previous repainting/refurbishment works evident. Some were unable to be tested, appearing to be painted shut. Cracked glazing panes were noted, particularly to the sun room which will require attention in the short term. Additional cracks were noted to the front and rear bedrooms at first level and to the skylight at top level.</p> <p>The windows are of on an age where a considered maintenance programme will require to be put in place to ensure they are kept in satisfactory condition.</p>

This will require on-going maintenance.</p> <p>The store at the foot of the grounds has overgrown with ivy and no internal inspection was carried out.</p> <p>Dampness was noted to the walls of the BBQ hut and to the roof timbers of the boiler store.</p>

Notes	<p>The outside areas were found to be generally well maintained. They are however bounded in parts by a traditional stone/rubble wall. No significant issues requiring urgent attention were noted, although this wall will require monitoring/maintenance.</p> <p>There is a lean to fencing and some decay.</p> <p>There are large trees on site and a check should be made to ascertain if any Tree Preservation Orders are in place. The trees are in influencing distance of the main property and some are in very close proximity to the garage. These will require monitoring and ongoing maintenance.</p>

Notes	<p>Within the limits of our inspection these generally appeared in fair condition consistent with age. During redecoration some plaster filling/repair may be required.</p> <p>Staining was noted to the ceiling of an upper bedroom. This was tested and found to be dry although should be monitored. Our inspection followed a period of heavy rainfall.</p>

Notes	<p>Within the limits of our inspection these generally appeared in fair condition consistent with age. During redecoration some plaster filling/repair may be required.</p>

Notes	<p>The internal walls are largely covered with decorative finishes. General plaster blemishes were noted and during routine redecoration some plaster filling may be necessary.</p> <p>No access to the sub-floor chamber was possible at the time of our visit to the property. Within the limitations of our inspection there was no indication to suggest significant defects in this area. It will however be appreciated that the area was not inspected and therefore no guarantees can be provided in this regard.</p>

It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.</p>

Notes	<p>The plumbing and fittings appear of copper/pvc piping where seen and appeared in serviceable condition but was not tested.</p> <p>The sanitary fittings appear in serviceable condition from our visual inspection. No tests were carried out. A level of modernisation has been carried out throughout in the past. Waterproof seals were generally intact at the time of our inspection. No high moisture levels or suspect flooring were noted to the limited accessible areas surrounding.</p>

4. Valuation and conveyance issues

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

The property is understood to be Category `B` Listed.

We noted no significant recent alterations.

Estimated reinstatement cost for insurance purposes

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than **£1,250,000** (One Million, Two Hundred and Fifty Thousand Pounds Sterling).

Valuation and market comments

£625,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of **£625,000** (Six Hundred and Twenty-Five Thousand Pounds Sterling).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

TERMS AND CONDITIONS OF SINGLE SURVEY

GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. *

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box. Yes

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Report may give rise to a conflict of interest and if this is of concern to any party they are advised to seek their own independent advice.

The Report and any expressions or assessments in it are not intended as advice to the Seller or Purchaser or any other person in relation to an asking price or any other sales or marketing decisions.

The Report is based solely on the Property and is not to be relied upon in any manner whatsoever when considering the valuation or condition of any other property.

If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

1.3 Liability

The Report is prepared with the skill and care reasonably to be expected of a competent residential surveyor who is a member of the Royal Institution of Chartered Surveyors.

2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, **visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.**

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. 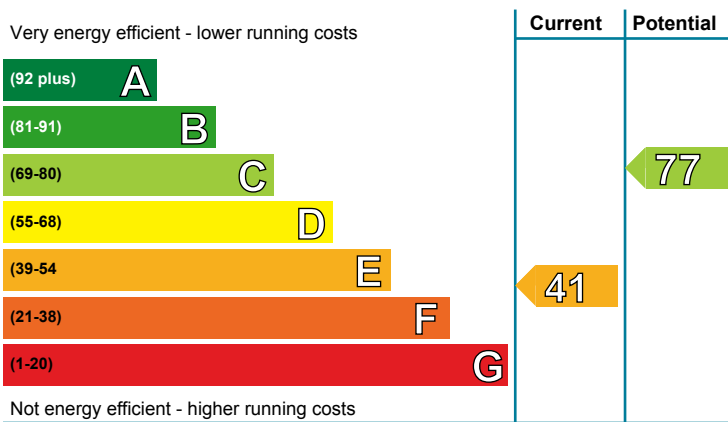

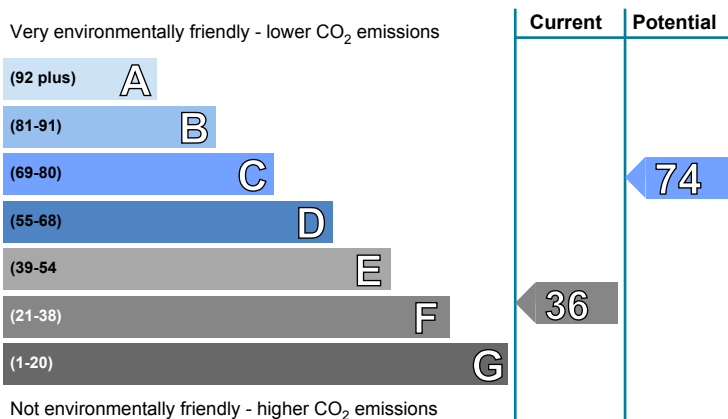


Energy Efficiency Rating

The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 65 kg CO₂/m²/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 24 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 15.1 tonnes per year. 



This section offers additional information and advice on the recommended improvement measures for your home

1 Room-in-roof insulation

Insulating roof rooms will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. If it has a flat ceiling insulation can usually be added above the ceiling, and sloping ceilings and walls of roof rooms can be insulated using an internal lining board. Roof voids must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about roof room insulation and details of local contractors can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). Building regulations generally apply to this work so it is best to check this with your local authority building standards department.

2 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide long-lasting weather protection. Further information can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

3 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

4 Heating controls (room thermostat)

The heating system should have a room thermostat to enable the boiler to switch off when no heat is required. A competent heating engineer should be asked to do this work. Insist that the thermostat switches off the boiler as well as the pump and that the thermostatic radiator valve is removed from any radiator in the same room as the thermostat. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

5 Condensing boiler

A condensing boiler is capable of much higher efficiencies than other types of boiler, meaning it will burn less fuel to heat this property. This improvement is most appropriate when the existing central heating boiler needs repair or replacement, however there may be exceptional circumstances making this impractical. Condensing boilers need a drain for the condensate which limits their location; remember this when considering remodelling the room containing the existing boiler even if the latter is to be retained for the time being (for example a kitchen makeover). Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

6 Double glazed windows

Double glazing is the term given to a system where two panes of glass are made up into a sealed unit. Replacing existing single-glazed windows with double-glazed windows will improve comfort in the home by reducing draughts and cold spots near windows. Double-glazed windows may also reduce noise, improve security and combat problems with condensation. Building regulations apply to this work and planning permission may also be required, so it is best to check with your local authority on what standards need to be met. A building warrant is not required if the windows comply with the current requirements.

7 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

Low and zero carbon energy sources
