1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Neighbourhood and Location	<p>The subjects are situated within an established and popular residential area a short distance to the east of Errol, where neighbouring properties were considered to comprise of varied age and character.</p> <p>Everyday amenities are available from Errol, with a both Perth and Dundee providing a wider range of facilities and essential services.</p>

Weather	It was raining at the time of our inspection.
Chimney Stacks	<p>There is a mutual rendered masonry chimney stack with cement flashing beneath.</p> <p>Visually inspected with the aid of binoculars where appropriate.</p>
Roofing including Roof Space	<p>The roof is mainly pitched, overlaid with slates and finished with metal ridging. There are flat roof structures over parts of the dwelling surfaced where seen with mineral felt sheets.</p> <p>The roof void was accessed via a ceiling hatch and fixed metal ladder. The void is partially floored, with insulation laid between the supporting joints of the ceiling beneath.</p> <p>Sloping roofs were visually inspected with the aid of binoculars where appropriate.</p> <p>Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.</p> <p>Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. Stored contents restricted our inspection.</p> <p>There is a timber shed attached to the garage, with the roof over surfaced with mineral felt sheets.</p> <p>Visually inspected.</p>

Outside Areas and Boundaries	<p>The property is approached by means of a private road over which it is presumed a right of access is held. Burden for upkeep and repairs will require to be confirmed.</p> <p>There is a small enclosed rear garden bounded by timber fences.</p> <p>There are private enclosed areas of garden to the front. The boundaries are of timber fence and established hedgerow. The ground is moderately sloping and is bounded to north by a small stream/watercourse.</p> <p>Visually inspected.</p>
Ceilings	<p>The ceilings are lined with decorative PVC panels.</p> <p>Visually inspected from floor level.</p>
Internal Walls	<p>The internal walls are strapped and lined with plasterboard.</p> <p>Visually inspected from floor level.</p> <p>Using a moisture meter, walls were randomly tested for dampness where considered appropriate.</p>
Floors Including Sub-Floors	<p>The floors are consistent with suspended timber construction. Fitted floor coverings restricted our assessment and no sub-floor access was obtained.</p> <p>It is not unusual to discover areas of past water spillage when floor coverings are removed in kitchen and bathroom compartments, revealing the need for further repair and maintenance work.</p> <p>Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.</p> <p>Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.</p> <p>Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch .</p>

Internal Joinery and Kitchen Fittings	<p>The interior doors are of panelled and part glazed timber installations. The internal joinery includes timber and PVC skirting boards, door facings and surrounds.</p> <p>There is a modern fitted kitchen consisting base/wall cabinets and work surfaces.</p> <p>Built-in cupboards were looked into but no stored items were moved.</p> <p>Kitchen units were visually inspected excluding appliances.</p>

Gas	<p>There is no mains gas supplied.</p> <p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Water, Plumbing and Bathroom Fittings	<p>Mains water. The visible plumbing consisted of copper and PVC components.</p> <p>Bathroom: - white fitted suite consisting of a toilet, wash basin and bath with an electric overhead shower.</p> <p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.</p>

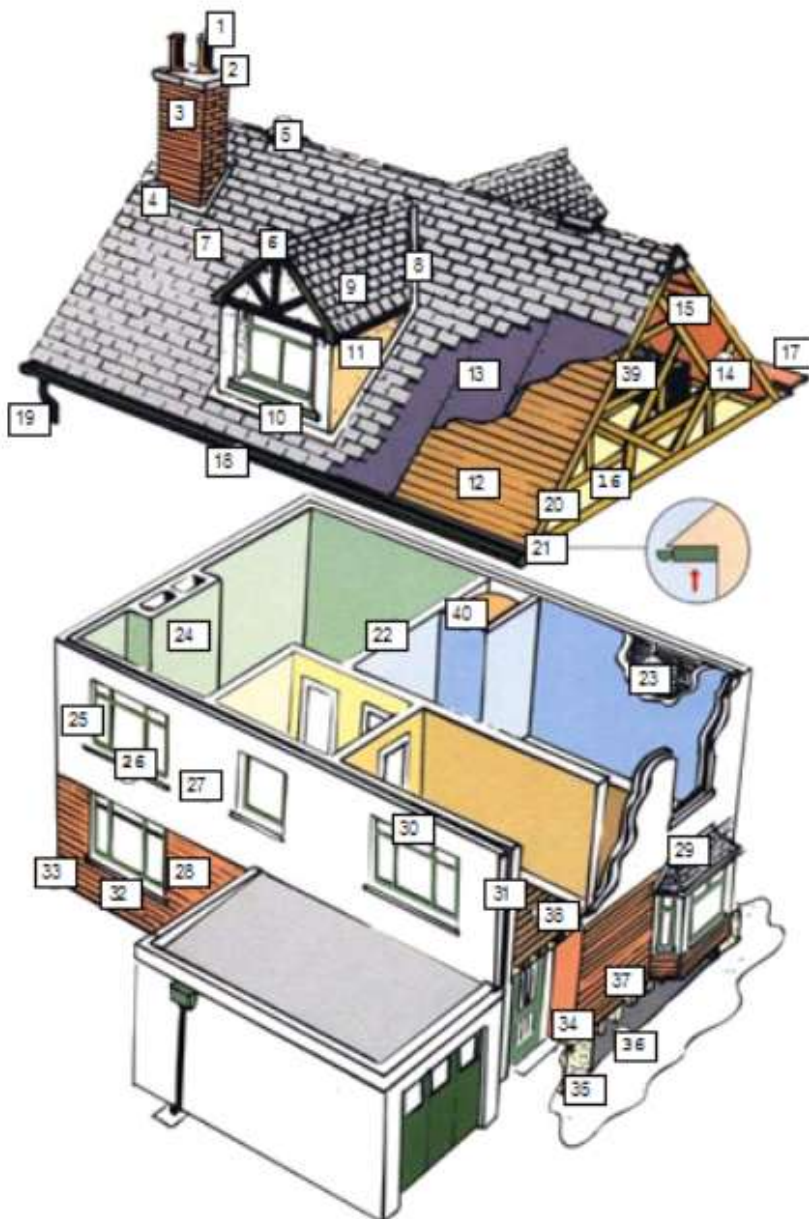
Heating and Hot Water	<p>There is a system of electric heating consisting of wall mounted radiators with time and temperature controls.</p> <p>Hot water is via an electric immersion installed within a foam insulated cylinder.</p> <p>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.</p>

Drainage	<p>There is a private drainage system consisting of a communal septic tank, this serves the subject and two neighbours. This was not inspected and is presumed to have been emptied and maintained as required.</p> <p>Drainage covers etc were not lifted.</p> <p>Neither drains nor drainage systems were tested.</p>

Fire, Smoke and Burglar Alarms	<p>Visually inspected. No tests whatsoever were carried out to the system or appliances.</p> <p>New smoke alarm standards were introduced in Scotland in February 2022. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.</p>

Additional limits to Inspection	<p>The property was occupied and furnished at the time of our inspection.</p> <p>Fitted floor coverings restricted our inspection and no access was obtained to inspect the sub-floor.</p> <p>The services including the heating, hot water and drainage systems were not tested.</p> <p>Our external inspection was carried out from ground level, with limited sight lines to the flat roofed areas.</p> <p>Stored contents within the garage restricted our inspection.</p> <p>It is not within the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.</p> <p>No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or in neighbouring properties.</p> <p>It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.</p>

Notes	There is evidence of settlement in the building noted both internally and externally but this is not inconsistent with a property of this age and type and on the basis of a single inspection appeared to be historic and longstanding in nature.

 Dampness, Rot and Infestation	
Repair Category	2
Notes	Elevated moisture readings were recorded to the internal face of several outer walls consistent with condensation. There is stained plaster/surface decoration and lifted wallpaper to the outside wall of the small bedroom, where our inspection was restricted by the position of a free standing wardrobe. Condensation should be alleviated through a balance of both heat and ventilation. This will require to further monitored and it would be prudent to seek further advice from a reputable timber and damp specialist contractor.

 Chimney Stacks

Notes	There are stained areas of render. Deterioration was noted to the flashing and some attention will be required through the course of normal routine maintenance.

	Roofing including Roof Space
Repair Category	2
Notes	<p>There are several displaced and broken slates with some areas of raised ridging. The roof covering is now of an age which will require regular careful attention and it would be prudent to seek the advice of a roofing contractor to comment on its current condition and expected lifespan.</p> <p>The felt roofed areas are of older appearance. The lifespan of the flat roofed areas/materials is difficult to predict. These structures and coverings will require regular careful maintenance and eventual replacement. The service history of the roofing material should be confirmed.</p>

Notes	<p>There are areas of corrosion and stained patches to the outer walls consistent with spills or leakage. Attention is required to areas of the rainwater goods system where deterioration has occurred.</p>

Notes	<p>Within the limitations of our inspection there was no evidence noted of significant defect. Normal routine maintenance will be required.</p>

Notes	There is no provision for permanent ventilation to several of the windows, with some restricted movement noted when tested. The windows are of an age and type where periodic attention to the sealed units, internal rubber seals, hinges and mechanisms should be allowed for as part of a programme of normal routine maintenance.

Notes	Within the limitations of our inspection there was no evidence noted of significant defect. Normal decoration maintenance will be required.

Notes	The nature of construction will necessitate the requirement for regular careful maintenance, with particular attention to the external fabric and roof materials.

We know of no recent flood events having affected the subjects, and have assumed that there are no issues in this respect, and that insurance can be obtained on normal terms. Notes	Typical plaster blemishes were noted and some attention will be required through the course of normal decorative maintenance.


	Floors including Sub-Floors
Repair Category	1
Notes	Typical to properties of this type and age, there are some areas of loose fitted timber floor where joinery repairs may be preferable. Fitted floor coverings restricted our inspection and no sub-floor access was obtained.


	Internal Joinery and Kitchen Fittings
Repair Category	1
Notes	The internal joinery appeared in a condition consistent with age and normal use with no significant defects noted. Normal routine maintenance will be required.


	Chimney Breasts and Fireplaces
Repair Category	2
Notes	<p>Elevated moisture levels were recorded to the base of the stove, where the wallpaper was noted to have lifted. The source of the moisture will require to be further investigated and remedial repairs actioned as required.</p> <p>It is assumed that the wood burner has been installed in accordance with the manufacturer's recommendations in particular regard to flueing and ventilation. The appliance was not tested.</p> <p>All flue linings should be checked, repaired if necessary and swept prior to the stove being reused.</p>

It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.</p>

The purchaser has five working days from settlement to inform the seller of any issues and it is advised that systems are checked within this timeframe.</p>

4. Valuation and Conveyance Issues

Replacement windows have been installed and we advise that the vendors be approached to confirm compliance or otherwise with current Building and if applicable Planning Regulations.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate.

The property is approached by means of a private road over which it is presumed a right of access is held. Burden for upkeep and repairs will require to be confirmed through reference to the title information.

Drainage is to a communal private septic tank system. This was not inspected. It assumed to have been suitably registered and maintained throughout its history and a copy of relevant documentation in this regard should be obtained prior to purchase.

There is an adjacent stream/watercourse, with the subjects situated within an area which is deemed to be a flood risk. We know of no recent flood events having affected the subjects, and have assumed that there are no issues in this respect, and that insurance can be obtained on normal terms. Estimated Reinstatement Cost for Insurance Purposes

£425,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £425,000 (Four Hundred and Twenty Five Thousand Pounds Sterling).

TERMS AND CONDITIONS OF SINGLE SURVEY

GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. *

1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

1.3 Liability

The Report is prepared with the skill and care reasonably to be expected of a competent residential surveyor who is a member of the Royal Institution of Chartered Surveyors.

The Report is addressed to the Seller and is prepared in the expectation that it (or a complete copy) along with these Terms and Conditions (or a complete copy) would be (or, as the case might be, would have been) disclosed and delivered to:

- the Seller;
- any person(s) noting an interest in purchasing the Property from the Seller;
- any person(s) who make(s) (or on whose behalf is made) an offer to purchase the Property, whether or not that offer is accepted by the Seller;
- the Purchaser; and
- the professional advisors of any of these.

The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

Graham + Sibbald's total liability to the Client (and any third party relying upon this report) under this Agreement (including liability in contract, tort (including negligence), breach of statutory duty, or otherwise) shall be limited to the lower of the following : a) 25% of the valuation or b) £250,000.

1.4 Generic Mortgage Valuation Report

The Surveyors are entitled to refrain from delivering the Report to anyone until the fee and other charges for it notified to the Seller have been paid. Additional fees will be charged for subsequent inspections and Reports, including replacement home reports.

1.8 Cancellation

The Seller will be entitled to cancel the inspection by notifying the Surveyor's office at any time before the day of the inspection.

The Surveyor will be entitled not to proceed with the inspection (and will so report promptly to the Seller) if after arriving at the Property, the Surveyor concludes that it is of a type of construction of which the Surveyor has insufficient specialist knowledge to be able to provide the inspection satisfactorily. DESCRIPTION OF THE REPORT

2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, **visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.**

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Report of Property that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

2.3.1 Category 3:

Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the Property or cause a safety hazard. Estimates for repairs or replacement are needed now.

2.3.2 Category 2:

Repairs or replacement requiring future attention, but estimates are still advised.

2.3.3 Category 1:

No immediate action or repair is needed.

The last section of the Report contains matters considered relevant to the conveyancer (solicitor). It also contains the Surveyor's opinion both of the market value of the Property and of the re-instatement cost, as defined below.

The subjects are situated within an established and popular residential area a short distance to the east of Errol, where neighbouring properties were considered to comprise of varied age and character. Everyday amenities are available from Errol, with a both Perth and Dundee providing a wider range of facilities and essential services.

The property was found to be in a condition consistent with age and type, with no significant items of repair outstanding which would materially affect our valuation reported. There are some items of wear and tear which are consistent with age and normal use, which will require some attention through the course of normal routine maintenance.

Replacement windows have been installed and we advise that the vendors be approached to confirm compliance or otherwise with current Building and if applicable Planning Regulations.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate.

The property is approached by means of a private road over which it is presumed a right of access is held. Burden for upkeep and repairs will require to be confirmed through reference to the title information.

Drainage is to a communal private septic tank system. This was not inspected. It assumed to have been suitably registered and maintained throughout its history and a copy of relevant documentation in this regard should be obtained prior to purchase.

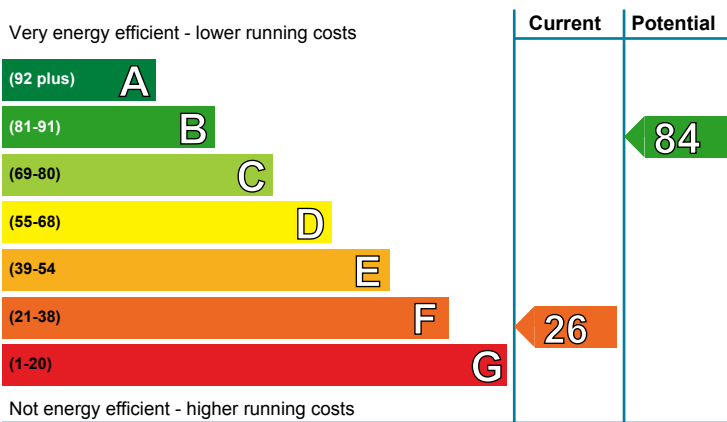

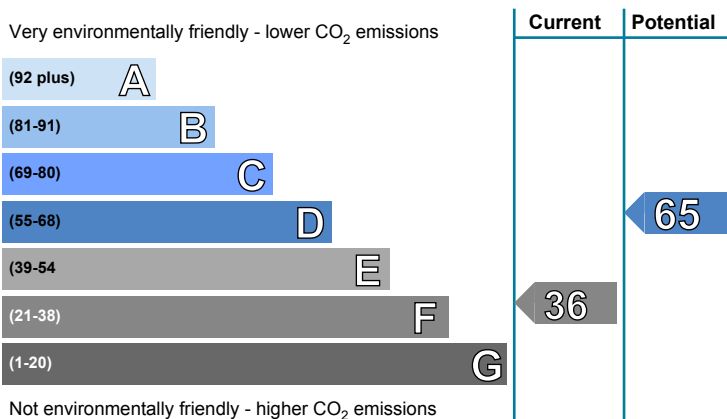

The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. The impact of your home on the environment

1 Flat roof or sloping ceiling insulation

Insulating a flat roof or sloping ceiling will significantly reduce heat loss through the roof; this will improve levels of comfort, reduce energy use and lower fuel bills. Insulation can be placed on top of the roof under the waterproof membrane and should particularly be considered when the waterproofing needs to be replaced. Further information about roof insulation and details of local contractors can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). Building regulations generally apply to this work so it is best to check with your local authority building standards department.

2 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide long-lasting weather protection. Further information can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

3 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

4 Floor insulation (solid floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Insulating solid floors can present challenges; insulation laid on top of existing solid floors may impact on existing doors and finishes whilst lifting of a solid floor to insert insulation below will require consideration of the potential effect on both structural stability and damp proofing. It is advised to seek advice from a Chartered Structural Engineer or a registered Architect about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work and may also require a building warrant so it is best to check with your local authority building standards department.

5 High heat retention storage heaters

Modern storage heaters are less expensive to run than the direct acting, on-peak heating system in the property. A dual-rate electricity supply is required to provide the off-peak electricity that these heaters use; this is easily obtained by contacting the energy supplier. Ask for a quotation for high heat retention heaters with automatic charge and output controls. A dual-immersion cylinder, which can be installed at the same time, will provide cheaper hot water than the system currently installed. Installations should be in accordance with the national wiring standards. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified electrical heating engineer. Ask the engineer to explain the options, which might also include switching to other forms of electric heating.

6 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

7 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

Low and zero carbon energy sources
