1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	The subjects comprise a purpose built third and attic floor maisonette forming part of a mid-terraced four storey plus attic tenement building containing eight flats.
Accommodation	THIRD FLOOR - Hallway, Lounge, Dining Room, Dining Kitchen, Bathroom with separate Shower Enclosure and WC, and Shower Room with WC ATTIC FLOOR - Landing, & Three Bedrooms

Neighbourhood and Location	The subjects are located to the north of Dundee City centre within the Stobswell area, directly opposite Morgan Academy. The surrounding properties are mainly of a similar age and character and all amenities are available within easy reach.
Age (Year Built)	1883
Weather	Dry.

Chimney Stacks Visually inspected with the aid of binoculars where appropriate. There are a number of stone chimney stacks serving the building and these incorporate cement and metal flashing details. Some of the chimney stacks were noted to be capped. **Roofing including Roof Space** Sloping roofs were visually inspected with the aid of binoculars where appropriate. Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally. Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so. The roof is of pitched timber construction externally laid in slate incorporating metal ridging and hips. The roof covering incorporates two slate clad dormer projections and a curved dormer projection clad with metal sheeting. Access to the roof space is via a hatch within the main bedroom. The roof void is insulated and only a restricted head and shoulders inspection was carried out. There is also a hatch within the stairwell although this was inaccessible due to its location over the stairs and its height above the landing. **Rainwater Fittings** Visually inspected with the aid of binoculars where appropriate. The rainwater fittings are of PVC design. Main Walls Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

The main walls are of solid stone construction, internally lined.

Windows, External Doors and Joinery	Internal and external doors were opened and closed where keys were available.
	Random windows were opened and closed where possible.
	Doors and windows were not forced open.
	The windows are of uPVC double glazed design.
	Access to the property is via a timber entrance door.
External Decorations	Not applicable.
Conservatories / Porches	None.
Communal Areas	Circulation areas visually inspected.
	Access to all flats within the building is via a communal entrance and stairwell.
Garages and Permanent	Visually inspected.
Outbuildings	Outbuildings comprise a terraced store within the garden ground to the rear of the building. These are of brick and timber construction with a slate roof over.
Outside Areas and Boundaries	Visually inspected.
	There is a communal area of garden laid out to the rear of the property and this appears to be shared with the residents of 12 Forfar Road. The boundaries comprise a mixture of concrete block walls and the main walls of the surrounding properties.
Ceilings	Visually inspected from floor level.
Comings	
	The ceilings are of timber lath in plaster and plasterboard type with a papered and painted finish. The ceilings are coombed at attic floor level and there are ornate and plain cornicing features within the property.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate. The internal walls are of masonry construction plastered on the hard and timber lath in plaster. Internal surfaces are papered and painted and there are areas clad in tiles and decorative panelling.

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted. Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point. Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch. The flooring is of suspended timber construction. The floors were fully covered at the time of our inspection.

Internal Joinery and Kitchen Fittings	Built-in cupboards were looked into but no stored items were moved. Kitchen units were visually inspected excluding appliances.
	The internal doors are of timber panel design.
	The kitchen comprises a range of units in a modern style.
	The main staircase is of timber construction and there are timber steps within the lounge.

Chimney Breasts and Fireplaces	Visually inspected. No testing of the flues or fittings was carried out.
	There are fireplaces within the property although these appear to be for decorative effect only.

Electricity

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Mains supply. The meter and consumer unit are located within a hatch box in the entrance hallway.

Gas

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Mains supply.

Water, Plumbing and Bathroom Fittings

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Mains supply. There is a stainless steel sink unit within the kitchen and where viewed, the plumbing is of PVC and copper design.

The sanitary fittings are modern. The bathroom comprises a toilet, two wash-hand basins, free standing bath and shower enclosure with plumbed-in shower over. The shower room comprises a toilet, wash-hand basin and shower enclosure with electric shower over.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances. Space heating is by means of a gas fired system. There is a Worcester Greenstar condensing combination boiler located within the small cupboard in the kitchen and this serves wall mounted radiators and towel rails. The central heating system provides domestic hot water.

	No tests whatsoever were carried out to the system or appliances.
	New smoke alarm standards were introduced in Scotland in February
	2022 and it is likely that some properties may require additional works to
	meet these standards. In instances where alarms are in place, no tests
	whatsoever have been carried out and we cannot confirm if the system
	complies with the most recent regulations. Any potential purchaser
	should satisfy themselves as to whether the current system meets with
	regulations or otherwise.
	Smoke and fire alarms were noted.

Additional limits to Inspection

Only the subject flat and internal communal areas giving access to the flat were inspected.

If the roof space or under-building / basement is communal, reasonable and safe access is not always possible. If no inspection was possible, this will be stated. If no inspection was possible, the surveyor will assume that there are no defects that will have a material effect on the valuation.


The building containing the flat, including any external communal areas, was visually inspected only to the extent that the surveyor is able to give an opinion on the general condition and standard of maintenance.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

2. Condition

Notes	There is evidence of settlement in the building noted both internally and externally but this is not inconsistent with a property of this age and type and on the basis of a single inspection appears to be longstanding.

	Dampness, Rot and Infestation
Repair Category	2
Notes	Isolated elevated moisture meter readings were noted to a section of coombed ceiling within the main bedroom. This appear to be as a result of past rainwater ingress. Damp staining was noted within the communal stairwell around the skylight and some decay was noted to the timber surround to the roof space hatch. As a precautionary measure, it would be prudent to have the property inspected by a timber and damp specialist contractor prior to committing to purchase. A check should be made to ascertain if there is any documentation available in respect of past specialist treatment works having been carried out to the building as a whole.

Notes	The stonework is typically weathered and there is evidence of some vegetation
	growth which should be removed. Where viewed, the flashings serving the chimney
	stacks appear to have been renewed. It should appreciated that the chimney stacks
	are of an age where on-going maintenance will be required, particularly to flashing
	details to ensure water tightness.

	Roofing including Roof Space
Repair Category	2
Notes	It is however understood that the roof coverings were overhauled in 2009. Checks should be made to ascertain if there is any documentation. It should be appreciated that as the roof covering ages it will require ongoing communal maintenance and an annual inspection is recommended. Internally, there is an inadequate firebreak separation wall. This should be improved for fire protection and security purposes.

	Rainwater Fittings
Repair Category	1
Notes	At the time of our inspection there was no evidence of damp staining/water staining on wall surfaces which would indicate leakage. It should be noted that it was not raining at the time of our inspection.

	Main Walls
Repair Category	1
Notes	The main outer walls of the property generally appeared in fair order consistent with age.



Windows, External Doors and Joinery

Repair Category	1
Notes	The windows have been upgraded and where tested these functioned adequately.
	Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/repair will be required as part of an ongoing maintenance programme.
	Double glazed windows may be prone to misting/interstitial condensation which can be more evident and can change in certain temperatures/weather conditions.

	Communal Areas

Notes	Typical wear and tear was noted to the decorative finishes throughout the stairwell and the rear-most entrance door is weathered. As per dampness, rot and infestation, damp staining was noted within the ceiling of the stairwell, around the skylight. This is likely due to water ingress. Some decay was noted to the timber surround to the roof space hatch as a result.

Notes	The garden shed is in fair condition consistent with age

	Outside Areas and Boundaries
Repair Category	1
Notes	The boundaries appear reasonably well defined and are in adequate condition. Regular maintenance will be required. You should verify with your conveyancer the extent of the boundaries attaching to the property.

	Ceilings
Repair Category	1
Notes	Uneven and blemished plasterwork noted. The ceilings are of lath in plaster construction and the strength of this type of ceiling depends on how well the plaster keys into the timber laths.

	Internal Walls

Notes	The internal walls are largely covered with decorative finishes. During routine redecoration some plaster filling may be necessary.

Notes	There is a slight run in the flooring timbers appearing to be as a result of previous movement. On the basis of a single inspection this appears long-standing and non-progressive.

Notes	The internal joinery is mainly on original lines and no evidence of any significant defect was apparent. There are distorted door surrounds as a result of past internal movement. The kitchen units are of a modern type and appeared in good condition for their age and purpose.

Notes	All flue linings should be checked, repaired if necessary and swept prior to the fires being reused.

Notes	The property is well presented.

Notes	The electrical installation has been partially upgraded with the installation of a modern consumer unit, although it is unclear the extent of the rewiring that has been carried out. There are sockets mounted on skirting boards which would not comply with the current building regulations.
	The Institution of Engineering and Technology recommends that inspections and testing are undertaken at least every ten years and on a change of occupancy. It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.

Notes	In the interest of safety all gas appliances should be checked by a Gas Safe Registered Engineer.

Notes	The plumbing and fittings appear of copper/pvc piping where seen and appeared in serviceable condition but was not tested.			
	The sanitary fittings have been upgraded and we noted no evidence of any significant defect.			
	The water proof seal around the main shower enclosure is worn.

Notes	The central heating boiler has been upgraded in the past to a condensing type although it should be appreciated that boilers have a limited life only and a copy of relevant installation/servicing documentation should be obtained in order to better advise on its current condition and expected lifespan.

Notes	The property is thought to be connected to a main sewer. There was no surface evidence to suggest the system is choked or leaking.

4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

The subjects form part of a block of flats and it has been assumed that maintenance/repair costs of the common parts of the building and external grounds will be shared on an equitable basis with the adjoining proprietors. It is therefore assumed that the costs of repairs detailed within this report which relate to these areas should be apportioned accordingly, although exact liability should be confirmed.

There is no evidence of any recent alterations.

Estimated Reinstatement Cost for Insurance Purposes

£420,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £420,000 (Four Hundred and Twenty Thousand Pound Sterling).

Valuation and Market Comments

£150,000

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

Market Value assuming vacant possession is £150,000 (One Hundred and Fifty Thousand Pounds Sterling).

TERMS AND CONDITIONS OF SINGLE SURVEY GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. *

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box. Yes

1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. 1.4 Generic Mortgage Valuation Report

2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.





The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO₂ emissions, running costs and the savings possible from making improvements.

The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 50 kg CO₂/m²/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. This section offers additional information and advice on the recommended improvement measures for your home

1 Room-in-roof insulation

Insulating roof rooms will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. If it has a flat ceiling insulation can usually be added above the ceiling, and sloping ceilings and walls of roof rooms can be insulated using an internal lining board. Roof voids must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about roof room insulation and details of local contractors can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). Building regulations generally apply to this work so it is best to check this with your local authority building standards department.

2 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide long-lasting weather protection. Further information can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

3 Heating controls (room thermostat)

The heating system should have a room thermostat to enable the boiler to switch off when no heat is required. A competent heating engineer should be asked to do this work. Insist that the thermostat switches off the boiler as well as the pump and that the thermostatic radiator valve is removed from any radiator in the same room as the thermostat. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

Low and zero carbon energy sources

Low and zero carbon (LZC) energy sources are sources of energy that release either very little or no carbon dioxide into the atmosphere when they are used. Installing these sources may help reduce energy bills as well as cutting carbon.
