## 1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

<b>Description</b>	The subjects comprise a detached two storey villa.
<b>Accommodation</b>	GROUND FLOOR - Hallway, Lounge, Dining Room, Sun Room, Kitchen and Cloakroom with WC.  FIRST FLOOR - 3 Bedrooms and Bathroom with WC.
<b>Gross Internal Floor Area (m<sup>2</sup>)</b>	139m <sup>2</sup> or thereby
<b>Neighbourhood and Location</b>	The property is located approximately three miles east of Dundee City Centre within an established area of Broughty Ferry at the junction of Strathern Road and Victoria Road. Surrounding properties are of a mixed residential nature and adequate secondary shopping, public transport, social and educational facilities can be found within easy reach.
<b>Age (Year Built)</b>	Erected around 1955
<b>Weather</b>	Sunny and dry.

<b>Chimney Stacks</b>	<p>Visually inspected with the aid of binoculars where appropriate.</p> <p>The chimney is of brick construction served with metal flashings.</p>
<b>Roofing including Roof Space</b>	<p>Sloping roofs were visually inspected with the aid of binoculars where appropriate.</p> <p>Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.</p> <p>Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.</p> <p>The roof is of pitched timber construction, externally clad in concrete interlocking tiles with tiled ridging and cement skews. Access to the roof space is via a hatch within the upper floor hallway. The roof space was found to be fully insulated with insulation laid over joists and this restricted our inspection to a head and shoulders type only.</p>
<b>Rainwater Fittings</b>	<p>Visually inspected with the aid of binoculars where appropriate.</p> <p>The rainwater goods are of cast iron construction and these are well painted.</p>
<b>Main Walls</b>	<p>Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.</p> <p>The main walls are of cavity concrete block construction externally roughcast and incorporating natural stone features to the front elevation.</p>

<b>Windows, External Doors and Joinery</b>	<p>Internal and external doors were opened and closed where keys were available.</p> <p>Random windows were opened and closed where possible.</p> <p>Doors and windows were not forced open.</p> <p>The windows are of single glazed timber casement design, with single glazed leaded windows on the stairwell. Access to the property is via the original timber panelled door and there is a timber tongued and grooved door to the side of the property. uPVC double glazed French doors are provided within the sun room giving access to the garden.</p>
<b>External Decorations</b>	Visually inspected.
<b>Conservatories / Porches</b>	<p>Visually inspected.</p> <p>As stated, there is a sun room/conservatory to the rear of the property and this is of uPVC double glazing with a glazed roof over. The flooring within appears to be of floating timber.</p>
<b>Communal Areas</b>	Not applicable.
<b>Garages and Permanent Outbuildings</b>	<p>Visually inspected.</p> <p>There is a large, attached garage pertaining to the property. This has a small area of tiled roofing to the front with the majority of the roof being mono-pitched and laid in mineral felt. The main walls of the garage (which is constructed onto the boundary) are of brick construction, concrete panels and timber. Other outbuildings comprise a timber and felt garden shed.</p>
<b>Outside Areas and Boundaries</b>	<p>Visually inspected.</p> <p>The subjects are served with an adequate area of garden ground enclosed with original stone walls, timber fencing and concrete panels. The stone walls are partially retaining in nature and a restricted inspection of these was possible due to vegetation growth. Off-street parking is provided.</p>

<b>Ceilings</b>	<p>Visually inspected from floor level.</p> <p>The ceilings are of plasterboard design throughout with a papered or painted finish.</p>
<b>Internal Walls</b>	<p>Visually inspected from floor level.</p> <p>Using a moisture meter, walls were randomly tested for dampness where considered appropriate.</p> <p>The internal walls are of brick construction plastered on the hard and timber stud overlaid in plasterboard. Internal surfaces are papered and painted, with areas of decorative panelling and tiling within the kitchen and sanitary areas.</p>
<b>Floors Including Sub-Floors</b>	<p>Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.</p> <p>Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.</p> <p>Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.</p> <p>The flooring at ground floor level is of solid concrete construction while there is suspended timber flooring at first floor level. Due to fitted carpets and floor coverings, no detailed inspection was possible of the flooring. No sub floor inspection was possible as no accessible hatch could be located.</p>
<b>Internal Joinery and Kitchen Fittings</b>	<p>Built-in cupboards were looked into but no stored items were moved.</p> <p>Kitchen units were visually inspected excluding appliances.</p> <p>The internal doors are of timber flush panel and timber and glazed design. The kitchen units are semi-modern. Storage accommodation within is adequate. A timber stair adjoins ground to upper floor level.</p>

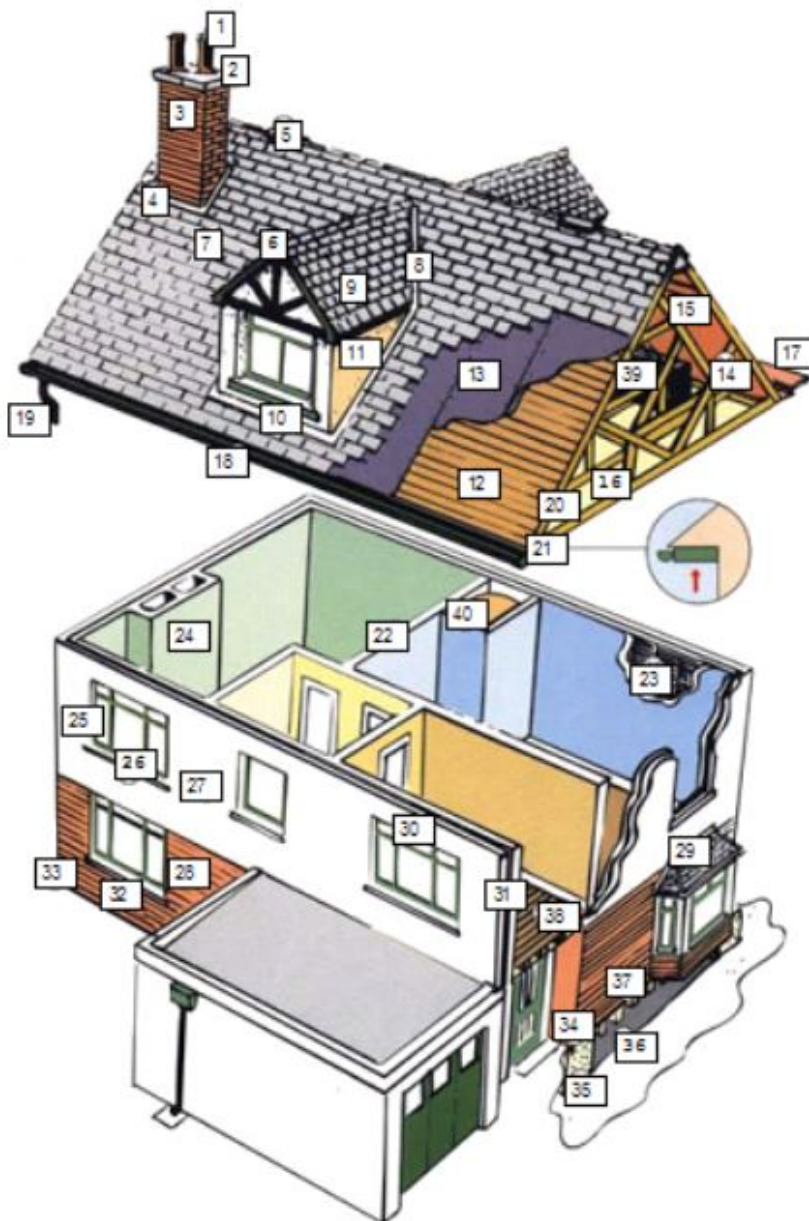
<b>Chimney Breasts and Fireplaces</b>	<p>Visually inspected. No testing of the flues or fittings was carried out.</p> <p>An imitation surround has been installed within the lounge and this was not checked or tested.</p>
<b>Internal Decorations</b>	Visually inspected.
<b>Cellars</b>	Not applicable.
<b>Electricity</b>	<p>Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>Mains supply.</p>
<b>Gas</b>	<p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>Mains supply.</p>
<b>Water, Plumbing and Bathroom Fittings</b>	<p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>Mains supply of water. There is a stainless steel sink unit in the kitchen and the plumbing below this is of PVC and copper design. The sanitary fittings within the cloakroom and bathroom are modern. There is an obsolete cold water tank within the roof space.</p>

<b>Heating and Hot Water</b>	<p>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.</p> <p>Space heating is by means of a gas fired system and the radiators are served with individual thermostats. There is a Potterton Promax condensing combination boiler within the kitchen and this is served with a fan-assisted flue. The central heating system provides domestic hot water.</p>
<b>Drainage</b>	<p>Drainage covers etc were not lifted.</p> <p>Neither drains nor drainage systems were tested.</p> <p>Presumed to be connected to the main public sewer.</p>
<b>Fire, Smoke and Burglar Alarms</b>	<p>Visually inspected.</p> <p>No tests whatsoever were carried out to the system or appliances.</p> <p>New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.</p> <p>Smoke alarms are provided within the property.</p>



<b>Additional limits to Inspection</b>	<p>Insulation has been laid over the roof joists and accordingly a head and shoulders inspection of the roof space was possible only.</p> <p>It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.</p> <p>No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.</p> <p>It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.</p>

<b>Notes</b>	At the time of our inspection there was no evidence of significant structural movement noted to affect the property within the limits of our inspection.

	<b>Dampness, Rot and Infestation</b>

<b>Notes</b>	There was no evidence found of significant dampness, rot or infestation within those areas of the property available for inspection.

	<b>Chimney Stacks</b>
<b>Repair Category</b>	1
<b>Notes</b>	No evidence of significant defect is apparent. The flashings are typically worn and will require regular maintenance.

	<b>Roofing including Roof Space</b>
<b>Repair Category</b>	2

Notes	<p>The roof covering is typically weathered and affected by some moss growth and cracked skews. A limited inspection was possible within the roof space, although it was noted that there is a wasp byke within this area.</p> <p>We understand the roof covering was renewed circa forty-five years ago and is now of an age where ongoing and regular maintenance will be required. It would be prudent to seek the advice of a roofing contractor to comment on its current condition and expected lifespan.</p>

Notes	The system is well painted. Weather conditions were dry at the time of our inspection.



## Main Walls

Notes	No evidence of significant defect is apparent. Minor patching repairs have been carried out in the past.



## Windows, External Doors and Joinery

Repair Category	2
Notes	<p>The windows are original and affected by typical ageing and weathering and also some condensation. Windows are ill-fitting at points.</p> <p>The external soffit areas appear to be laid in asbestos cement sheeting. The current informed view is that this presents no significant hazard to health unless cut or sanded resulting in dust within the air. The fascia timbers are rather weathered although well painted.</p>

Notes	As stated, external timbers are well painted although there is evidence of some decay below the painted finish to the fascia timbers.

Notes	No evidence of significant defect is apparent.

## Garages and Permanent Outbuildings

Notes	The garage is a basic structure. The roof covering over appears to have been renewed in the past, although felt roofs do have a limited life. The concrete panels were noted to be damaged and affected by corrosion and there are also asbestos cement panels within the garage area. The timbers are affected by weathering and decay and there is evidence of wood boring insect infestation internally. Repairs should be anticipated.

Notes	The boundaries appear reasonably well defined and are in adequate condition. Regular maintenance will be required. You should verify with your conveyancer the extent of the boundaries attaching to the property. The stone walls are affected by some vegetation growth, weathering and movement/cracking. Retaining walls should be monitored on a regular basis.

	<b>Ceilings</b>

Notes	No evidence of significant defect is apparent, although some blemishes are evident below the papered finish.

	<b>Internal Walls</b>
Repair Category	1
Notes	The internal walls are largely covered with decorative finishes. During routine redecoration some plaster filling may be necessary.

	<b>Floors including Sub-Floors</b>
Repair Category	1
Notes	Areas of loose/uneven flooring were noted.

	<b>Internal Joinery and Kitchen Fittings</b>
Repair Category	1
Notes	The internal joinery is generally in keeping with the age and type of property and appeared in fair condition consistent with age. The kitchen is on semi-modern lines and in adequate condition commensurate with its age. We cannot confirm if the glazing within internal doors is safety glass.

	<b>Water, Plumbing and Bathroom Fittings</b>

Notes	<p>The plumbing and fittings appear of copper/PVC piping where seen and appeared in serviceable condition but was not tested.</p> <p>The sanitary fittings are of modern style and type. It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.</p>

Notes	The system would now be regarded as semi-modern. This was not checked or tested. Ongoing maintenance and servicing should be carried out.

## 4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

### Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

A sun room/conservatory has been constructed to the rear of the property and it is assumed that any necessary consents were obtained. This should be confirmed.

### Estimated Reinstatement Cost for Insurance Purposes

£500,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than **£500,000** (Five Hundred Thousand Pounds Sterling).

### Valuation and Market Comments

£325,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of **£325,000** (Three Hundred and Twenty Five Thousand Pounds Sterling).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.



## TERMS AND CONDITIONS OF SINGLE SURVEY

### GENERAL

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. \*

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

#### 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Report may give rise to a conflict of interest and if this is of concern to any party they are advised to seek their own independent advice.

The Report and any expressions or assessments in it are not intended as advice to the Seller or Purchaser or any other person in relation to an asking price or any other sales or marketing decisions.

The Report is based solely on the Property and is not to be relied upon in any manner whatsoever when considering the valuation or condition of any other property.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

The subjects comprise a detached two storey villa located within a popular residential area of Broughty Ferry. Adequate facilities can be found within easy reach.

Externally, we noted no evidence of serious defect to the main fabric although typical ageing has occurred. The roof covering is original and will require ongoing maintenance and general repairs are required to the garage. Internally, fittings and fixtures are on serviceable lines and decoration is to a good standard throughout. While defects were noted, these are commonly found in a property of this type and as far as possible have been reflected in the valuation. 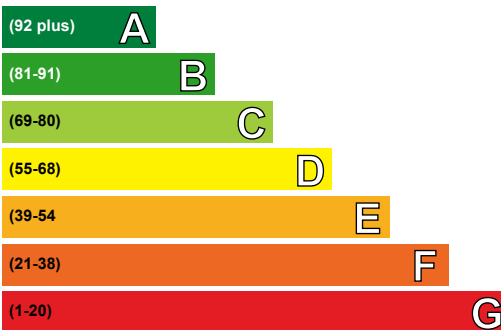

## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO<sub>2</sub> emissions, running costs and the savings possible from making improvements.


## The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 51 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 6.3 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 3.3 tonnes per year. You could reduce emissions even more by switching to renewable energy sources.




## About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

### 1 Cavity wall insulation

Cavity wall insulation, to fill the gap between the inner and outer layers of external walls with an insulating material, reduces heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. The insulation material is pumped into the gap through small holes that are drilled into the outer walls, and the holes are made good afterwards. As specialist machinery is used to fill the cavity, a professional installation company should carry out this work, and they should carry out a thorough survey before commencing work to ensure that this type of insulation is suitable for this home and its exposure. They should also provide a guarantee for the work and handle any building standards issues. Further information about cavity wall insulation and details of local installers can be obtained from the National Insulation Association ([www.nationalinsulationassociation.org.uk](http://www.nationalinsulationassociation.org.uk)).

### 2 Floor insulation (solid floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Insulating solid floors can present challenges; insulation laid on top of existing solid floors may impact on existing doors and finishes whilst lifting of a solid floor to insert insulation below will require consideration of the potential effect on both structural stability and damp proofing. It is advised to seek advice from a Chartered Structural Engineer or a registered Architect about this if unsure. Further information about floor insulation is available from many sources including [www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation](http://www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation). Building regulations generally apply to this work and may also require a building warrant so it is best to check with your local authority building standards department.

### 3 Draughtproofing

Fitting draughtproofing, strips of insulation around windows and doors, will improve the comfort in the home. A contractor can be employed but draughtproofing can be installed by a competent DIY enthusiast.

### 4 Low energy lighting

Replacement of traditional light bulbs with energy saving bulbs will reduce lighting costs over the lifetime of the bulb, and they last many times longer than ordinary light bulbs. Low energy lamps and fittings are now commonplace and readily available. Information on energy efficiency lighting can be found from a wide range of organisations, including the Energy Saving Trust (<http://www.energysavingtrust.org.uk/home-energy-efficiency/lighting>).

### 5 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at [www.microgenerationcertification.org](http://www.microgenerationcertification.org).

### 6 Double glazed windows

Double glazing is the term given to a system where two panes of glass are made up into a sealed unit. Replacing existing single-glazed windows with double-glazed windows will improve comfort in the home by reducing draughts and cold spots near windows. Double-glazed windows may also reduce noise, improve security and combat problems with condensation. Building regulations apply to this work and planning permission may also be required, so it is best to check with your local authority on what standards need to be met. A building warrant is not required if the windows comply with the current requirements.



## 7 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). ## Low and zero carbon energy sources
