1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	The subjects comprise a semi-detached two storey villa.

Neighbourhood and Location	The subjects are situated within an established residential location approximately two miles northeast of Dundee City centre. Surrounding properties are of a similar class and nature with adequate amenities available within easy reach.
Age (Year Built)	Erected circa 1900

Chimney Stacks

Visually inspected with the aid of binoculars where appropriate.

The chimneys serving the property are of solid stone and brick/harled construction. The flashings where seen from ground level are of lead design.

Roofing including Roof Space

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.

Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

The roof over the main property and rear outshoot are of pitched timber design overlaid in slate with slate hips and zinc ridging. There is a small flat felt roof over the rear bay.

The attic over the main property has been converted previously. Access was however gained to an area of the eaves and this area was found to be insulated. No access was gained to the apex over the main property. There is a hatch to the roof void over the rear outshoot. No access was possible to this area due to the positioning of the hatch which is directly above the shower cubicle. The hatch was removed and, where seen, this area was found to be insulated. If access can be provided then an inspection of this area will be carried out.

Rainwater Fittings

Visually inspected with the aid of binoculars where appropriate.

The rainwater goods are of PVC and cast iron design with valley gutters also incorporated into the roof structure.

Main Walls

Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

The main walls of the property are of solid stone construction with the rear outshoot appearing to be of solid brick design externally harled.

Windows, External Doors and Internal and external doors were opened and closed where keys were **Joinery** available. Random windows were opened and closed where possible. Doors and windows were not forced open. The windows are predominantly of aluminium casement double glazed design, although there are also timber casement double glazed and uPVC sash double glazed units. Access to the property would appear to be via the original timber panel and glazed front entrance door with a newer timber and glazed door to the rear. **External Decorations** Visually inspected. PVC finish to windows and doors, external timbers painted. Conservatories / Porches Visually inspected. There is a basic style conservatory to the rear of aluminium and glazed design.

Communal Areas	None

Garages and Permanent	Visually inspected.
Outbuildings	There is a single car garage pertaining to the property being of a lean-to brick design externally harled with the roof over pitched and laid in slate. Access to the garage is via an up and over door (not checked or tested) as well as a timber personnel door to the rear. The garage would appear to benefit from light and power, however this was not checked or tested. The inspection of the garage was restricted due to contents.

Outside Areas and Boundaries

Visually inspected.

There are garden grounds to the front, side and rear. There is a concrete laid driveway and path to the front with the rear garden predominantly laid in grass although there are also paved sections.

Boundaries are of stone and timber fencing design.

Ceilings

Visually inspected from floor level.

Ceilings would appear to be predominantly of the original timber lath and plaster with a number of the ceilings benefitting from ornate and plain cornice features. There is timber cladding to the ceiling within the kitchen with polystyrene tiles attached to the bathroom ceiling at first floor level.

Internal Walls

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

Internal partitions would appear to be of brick plastered on the hard and timber lath and plaster. There is timber panelling to the walls within the sitting room and entrance vestibule. Tiling and wet walling has been added to the walls within the bathroom.

Floors Including Sub-Floors

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.

Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so, and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.

Flooring within the property is of suspended timber construction with fitted floorcoverings throughout.

No access was gained to the sub-floor area as no access hatch could be found.

Internal Joinery and Kitchen Fittings

Built-in cupboards were looked into but no stored items were moved.

Kitchen units were visually inspected excluding appliances.

The internal doors are of timber panel, timber flush panel and timber and glazed design.

There is a fitted kitchen within the property with both base and wall units.

Access to the first floor level is via the original timber staircase. There is a timber stair leading to the attic, this is steep and narrow and would not comply with current building regulations.

There are no fitted wardrobes within the bedrooms although cupboard accommodation is typical for a property of this type and age.

Chimney Breasts and Fireplaces

Visually inspected. No testing of the flues or fittings was carried out.

There is a timber surround within the lounge with a living flame gas fire fitted. There is also a timber and brick surround within the sitting room with what would appear to be a gas fire. Neither were checked or tested. The remaining fireplaces would appear to have been blocked up.

Internal Decorations

Visually inspected.

Papered and painted.

Cellars

Electricity

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Mains supply of electricity with 13 amp power outlets within the main apartments. The consumer unit and meter are located under the stair.

Gas

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Mains supply of gas with the gas meter located within the lounge wall press.

Water, Plumbing and Bathroom Fittings

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Mains supply of water and plumbing, where seen, is of PVC and copper design. A stainless steel sink unit has been installed within the kitchen with bathroom fitments being on modern white lines with a separate shower cubicle. A semi-modern shower cubicle and wash hand basin have been installed within the rear bedroom. These works would appear to have been carried out in excess of 30 years ago.

There is a modern, white WC and wash hand basin within the cloakroom at ground floor level.

Heating and Hot Water

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

There is a full gas fired central heating system within the property with radiators located within the main apartments. The central heating piping where seen is of copper design with a number of the radiators benefitting from individual thermostatic controls.

Domestic hot water would appear to be provided via the central heating system with the boiler being of a Worcester wall mounted design located within the cloakroom at ground floor level. The hot water tank is located adjacent to the boiler and is of modern design and insulated.

Drainage

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

Drainage is assumed to be connected to the main public sewer.

Fire, Smoke and Burglar Alarms

Visually inspected. No tests whatsoever were carried out to the system or appliances. New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

Additional limits to Inspection

It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.


It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

The attic has been converted and this greatly restricted the inspection of the eves with no access to the apex, No access was gained of the roof void over the rear outshoot.

Limited inspection of the garage both internally and externally.

Vegetation restricted the inspection of the boundries.

2. Condition

	Structural Movement
Repair Category	1
Notes	There is evidence of movement, evident internally by a run in the flooring and cracking to the cornicing. Externally, cracking was noted to the stonework, including adjacent to the bay where pointing works have been carried out. On the basis of a single inspection the movement would appear to be longstanding and non-progressive.

	Dampness, Rot and Infestation
Repair Category	2
Notes	Damp meter readings were noted in areas within the property and accordingly, in line with good practice, the subjects will require to be inspected by a timber/damp proofing specialist firm, a report prepared and thereafter any necessary remedial works implemented under guarantee.

	Chimney Stacks
Repair Category	2
Notes	There is cracked and missing harling on the brick chimney stack to the rear. Remedial repairs will be required. The stone chimney stacks were found to be weathered in places and ongoing maintenance and repairs should be anticipated.

	Roofing including Roof Space
Repair Category	2
Notes	The roof coverings are of the original slate design. From ground level the inspection was limited. There are some slipped and broken slates. It may be the case that previous remedial repairs have been carried out and if so any documentation in respect to the works should be obtained and kept on file. The roof covering is now of an age where ongoing and regular maintenance will be required and it would be prudent to seek the advice of a roofing contractor to comment on its current condition and expected lifespan. The inspection of the eaves over the main roof void was extremely limited however, where seen, there is evidence of condensation and staining. No inspection was made of the roof void over the rear outshoot and accordingly no comment can be made as to its condition. As stated previously, there is a small flat felt roof over the rear bay, this would appear to be worn and may be near the end of its useful life.

	Rainwater Fittings
Repair Category	2
Notes	There is evidence of corrosion and possible leakage from the cast iron rainwater goods. One of the gutters were also found to be buckled. The rainwater goods should be inspected to fully ascertain their current condition.

	Main Walls
Repair Category	2
Notes	There are areas of general weathering to the stonework as well as cracking and open joints. Ongoing maintenance and repairs should be anticipated. There are areas of cracked and bossed harling on the rear outshoot and, again, ongoing maintenance and repairs will be required.

	Windows, External Doors and Joinery
Repair Category	2
Notes	The majority of the windows are of aluminium design. These would appear to have been installed in excess of 30 years ago and were found to be in fair condition only. Interstitial condensation was also noted to a number of the windows, including the timber windows within the sitting room and uPVC sash window within the kitchen. A number of the windows would appear to be near the end of their useful life. The windows will require to be fully inspected, their condition ascertained and costings obtained for any replacement.
	Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/repair will be required as part of an ongoing maintenance programme. Double glazed windows may be prone to misting/interstitial condensation which can be more evident and can change in certain temperatures/weather conditions.

	External Decorations
Repair Category	2
Notes	Renew external decoration.

	Conservatories / Porches
Repair Category	2
Notes	The conservatory is of lightweight construction and consideration should be given to either upgrading or replacement as required.

	Communal Areas
Repair Category	-

Notes	Not applicable.

	Garages and Permanent Outbuildings
Repair Category	2
Notes	The inspection internally was limited due to extensive contents with no inspection possible of the side elevation. There are areas externally of missing and bossed harling. Ongoing maintenance and repairs should be anticipated. Decay was noted to the door and window frames. Various joinery repairs will be required. Inspect and repair as necessary.

	Outside Areas and Boundaries
Repair Category	2
Notes	Garden grounds would appear to have been reasonably well maintained, however there is evidence of open joints and weathering to the stone boundaries. Remedial repairs will be required. The inspection of the boundaries was limited due to vegetation.

	Ceilings
Repair Category	2
Notes	There is evidence of cracking and unevenness to ceilings which are of lath and plaster construction. The strength of this type of ceiling depends on how well the plaster keys into the lath. Staining was noted to the ceiling below the flat roof. Inspect and repair as necessary.
	There are what would appear to be polystyrene ceiling tiles within the bathroom at first floor level. These should be removed as they may constitute a fire hazard.



Internal Walls

Repair Category	1
Notes	The internal walls are largely covered with decorative finishes. During routine redecoration some plaster filling may be necessary.

	Floors including Sub-Floors
Repair Category	1
Notes	Fitted floor coverings greatly restricted the inspection of the flooring. There is a run in the flooring, particularly noticeable at the bay window at first floor level. This would appear to be the result of previous movement. On the basis of a single inspection the movement would appear to be longstanding and non-progressive. There are a number of loose floorboards which will require to be nailed down in due course.
	No sub-floor inspection was made and accordingly no comment can be made as to the condition of the timbers within these areas.

	Internal Joinery and Kitchen Fittings
Repair Category	2
Notes	The kitchen units are of a semi-modern type and appeared in adequate order for their age and purpose. Consistent with age and usage, wear and tear was noted to localised sections of the cabinetry. It is therefore recognised that incoming purchasers may opt to modernise to suit individual tastes and requirements. As stated previously, the stair to attic level is steep and narrow and would not comply with current building regulations.

	Chimney Breasts and Fireplaces
Repair Category	1
Notes	All flue linings should be checked, repaired if necessary and swept prior to the fires being reused.

	Internal Decorations
Repair Category	1
Notes	Internal decoration is to a fair standard and will require to be upgraded to meet the purchaser's own requirements.

	Cellars
Repair Category	-
Notes	Not applicable.

	Electricity
Repair Category	2
Notes	The consumer unit has been upgraded in the past although it is unclear the extent of upgrading works having been carried out to concealed wiring. Any information as to past re-wiring works should be obtained, if available. It should be appreciated that only the most recently installed or re-wired properties comply with current regulations and as in all cases, we recommend that the system be checked prior to purchase by an NICEIC/Select registered electrical contractor. The Institution of Engineering and Technology recommends that inspections and testing are undertaken at least every ten years and on a change of occupancy. It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.

	Gas
Repair Category	1
Notes	In the interest of safety all gas appliances should be checked by a Gas Safe registered engineer.

	Water, Plumbing and Bathroom Fittings
Repair Category	2
Notes	It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis. Sanitary fittings are on mixed modern/semi-modern lines. The wash hand basin and shower cubicle within the rear bedroom at first floor level are of basic design and will require replacement in due course. Internal plumbing works comprise a mixture of copper and PVC fittings. There is the possibility of old style sections in concealed areas and it would be prudent to budget for upgrading in conjunction with other modernisation works.

	Heating and Hot Water
Repair Category	2
Notes	The central heating boiler would appear to have been replaced in the past. When these works were carried out is unknown. The radiators and pipework are however on older lines. The system should be inspected to ascertain the systems current condition.

	Drainage
Repair Category	1
Notes	The property is thought to be connected to a main sewer. There was no surface evidence to suggest the system is choked or leaking.

Unrestricted parking within 25 metres: For this purpose, 'Unrestricted parking' includes parking available by means of a parking permit. Restricted parking includes parking that is subject to parking restrictions, as indicated by the presence of solid yellow, red or white lines at the edge of the road or by a parking control sign, parking meters or other coinoperated machines.

4. Valuation and Conveyance Issues

Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

Estimated Reinstatement Cost for Insurance Purposes

£620,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £620,000 (Six Hundred and Twenty Thousand Pounds Sterling).

Valuation and Market Comments

£275,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £275,000 (Two Hundred and Seventy Five Thousand Pounds Sterling).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

TERMS AND CONDITIONS OF SINGLE SURVEY GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. *

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box. Yes

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

1.3 Liability

The Report is prepared with the skill and care reasonably to be expected of a competent residential surveyor who is a member of the Royal Institution of Chartered Surveyors.

The Report is addressed to the Seller and is prepared in the expectation that it (or a complete copy) along with these Terms and Conditions (or a complete copy) would be (or, as the case might be, would have been) disclosed and delivered to:

- the Seller
- any person(s) noting an interest in purchasing the Property from the Seller;
- any person(s) who make(s) (or on whose behalf is made) an offer to purchase the Property, whether or not that offer is accepted by the Seller;
- the Purchaser; and
- the professional advisors of any of these.



The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

Graham + Sibbald's total liability to the Client (and any third party relying upon this report) under this Agreement (including liability in contract, tort (including negligence), breach of statutory duty, or otherwise) shall be limited to the lower of the following: a) 25% of the valuation or b) £250,000.

1.4 Generic Mortgage Valuation Report

The Surveyors are entitled to refrain from delivering the Report to anyone until the fee and other charges for it notified to the Seller have been paid. Additional fees will be charged for subsequent inspections and Reports, including replacement home reports.

1.8 Cancellation

The Seller will be entitled to cancel the inspection by notifying the Surveyor's office at any time before the day of the inspection.

The Surveyor will be entitled not to proceed with the inspection (and will so report promptly to the Seller) if after arriving at the Property, the Surveyor concludes that it is of a type of construction of which the Surveyor has insufficient specialist knowledge to be able to provide the inspection satisfactorily. - the "Transcript Mortgage Valuation Report for Lending Purposes" means a separate report, prepared by the Surveyor, prepared from information in the Report and the generic Mortgage Valuation Report, but in a style and format required by the Lender. The Transcript Mortgage Valuation Report for Lending Purposes will be prepared with the skill and care reasonably to be expected from a Surveyor who is a member of the Royal Institution of Chartered Surveyors and who is competent to survey, value and report on the Property;

DESCRIPTION OF THE REPORT

2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Report of Property that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

2.3.1 Category 3:

Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the Property or cause a safety hazard. Estimates for repairs or replacement are needed now.

2.3.2 Category 2:

Repairs or replacement requiring future attention, but estimates are still advised.

2.3.3 Category 1:

No immediate action or repair is needed.

WARNING:

If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. The existence of Category 2 or Category 3 repairs may have an adverse effect on marketability, value and the sale price ultimately achieved for the Property. This is particularly true during slow market conditions when the effect can be considerable. Parts of the Property which cannot be seen or accessed will not be reported upon and this will be stated. 2.4 Services

However, comment is made where there is cause to suspect significant defects or shortcomings with the installations. No tests are made of any services or appliances.

2.5 Accessibility

A section is included to help identify the basic information interested parties need to know to decide whether to view a Property.

2.6 Energy Report

A section is included that makes provision for an Energy Report, relative to the Property. The Surveyor will collect physical data from the Property and provide such data in a format required by an accredited energy company. The Surveyor cannot of course accept liability for any advice given by the energy company.

2.7 Valuation & Conveyancer Issues

The last section of the Report contains matters considered relevant to the conveyancer (solicitor). It also contains the Surveyor's opinion both of the market value of the Property and of the re-instatement cost, as defined below.

"Market Value" is the estimated amount for which a property should exchange on the date of valuation within a willing buyer and willing seller in an arms-length transaction after proper marketing wherein the parties have each acted knowledgably, prudently and without compulsion. In arriving at the opinion of the Market Value the Surveyor also makes various standard assumptions covering, for example, vacant possession; tenure and other legal considerations; contamination and hazardous materials; the condition of uninspected parts; the right to use mains services; and the exclusion of curtains, carpets etc. from the valuation. In the case of flats, the following further assumptions are made that:

- There are rights of access and exit over all communal roadways, corridors, stairways etc. and to use communal grounds, parking areas, and other facilities:
- There are no particularly troublesome or unusual legal restrictions.

A valuation for mortgage is a limited inspection and report produced for building societies, banks and other lenders to enable them to make a lending decision. IT IS NOT A SURVEY. Unless otherwise stated the date of valuation will be the date of inspection.

This report is used to guide the lender on the market value of the Property for mortgage purposes and is carried out for this purpose alone. Although the inspection will be carried out by a valuer who will usually be a qualified surveyor it is not a detailed inspection of the Property, and only major visible defects will be noted. 



The energy efficiency rating of your home

About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

1 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide long-lasting weather protection. Further information can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

2 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

3 Low energy lighting

Replacement of traditional light bulbs with energy saving bulbs will reduce lighting costs over the lifetime of the bulb, and they last many times longer than ordinary light bulbs. Low energy lamps and fittings are now commonplace and readily available. Information on energy efficiency lighting can be found from a wide range of organisations, including the Energy Saving Trust (http://www.energysavingtrust.org.uk/home-energy-efficiency/lighting).

4 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

5 Replacement glazing units

Replacing existing double-glazed units with new high-performance units. Building regulations require that replacement glazing is to a standard no worse than previous; a building warrant is not required. Planning permission might be required for such work if a building is listed or within a conservation area so it is best to check with your local authority.

6 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent).
