#### 1. Information and Scope of Inspection


This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	The subjects comprise a detached one-and-a-half storey chalet style bungalow, originally constructed by Messrs Bett Homes to their `Leven` design.

## Chimney Stacks Visually inspected with the aid of binoculars where appropriate. The chimney stack is of brick construction, externally roughcast and served with metal flashings.

#### **Roofing including Roof Space**

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

The roof is of pitched timber construction externally clad in concrete interlocking tiles with tiled ridging and PVC capped skews.

Access to the roof void is via an eaves hatch within the upstairs landing cupboard. The roof space was found to be insulated over joists.

Accordingly, only a limited inspection around the hatch was possible.

There is no apex hatch within the property.

#### **Rainwater Fittings**

Visually inspected with the aid of binoculars where appropriate.

The rainwater goods are of PVC design.

#### **Main Walls**

Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

The main walls are of cavity brick construction, externally roughcast incorporating brick footings and timber weatherboarding features. It would appear that cavity wall insulation has been injected into the wall cavity, reflected by external drill holes, although we would confirm that no documentation in this regard has been viewed.

#### Windows, External Doors and Internal and external doors were opened and closed where keys were **Joinery** available. Random windows were opened and closed where possible. Doors and windows were not forced open. The windows are of a uPVC double glazed design. There is a timber Velux unit at upper floor level. Access to the property is via a timber and glazed front entry door and uPVC and glazed rear entry door. There are uPVC and double glazed bifolding doors within the rear bedroom which give access to the garden. **External Decorations** Visually inspected. The weatherboarding features are of timber design. The fascia/soffits are clad in PVC. Conservatories / Porches None. **Communal Areas** None. **Garages and Permanent** Visually inspected. **Outbuildings** There is a single garage located on-site. This is of sectional concrete panel construction and has a corrugated cement fibre roof over. The original roof has been overlaid in a membrane type material. The garage is served with a manual up-and-over door and a side uPVC door. **Outside Areas and Boundaries** Visually inspected. There are areas of private garden ground to the front and rear of the property and off-street parking is provided on a private drive. The site is sloping to the rear and incorporates retaining walls. The grounds are predominantly laid to lawn and a greenhouse is incorporated within the

rear garden. Boundaries comprise low concrete block walls and timber

fencing.

	The ceilings appear to be of plasterboard design throughout.

Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on. Mains supply of electricity. The consumer unit is located within the entrance vestibule.

# Water, Plumbing and Bathroom Fittings Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on. Mains supply of water. There is a sink unit in the kitchen and the plumbing, where viewed, is of PVC and copper design.

The shower room fittings are along modern lines and comprise a WC, wash-hand basin and plumbed-in shower in cubicle.

#### **Heating and Hot Water**

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

Space heating is by means of a gas fired system. There is a Worcester Greenstar condensing combination boiler located within the upstairs landing cupboard and this feeds wall mounted radiators. The central heating system appears to provide domestic hot water.

#### Drainage

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

Presumed to be connected to the main public sewer.

#### Fire, Smoke and Burglar Alarms

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

Smoke alarms are provided within the property.

#### **Additional limits to Inspection**


It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

Insulation has been laid over the roof joists and accordingly a head and shoulders inspection of the roof space was possible only.

It should be appreciated that the Home Report inspection is a nondisruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

Notes	At the time of our inspection there was no evidence of significant structural movement noted to affect the property within the limits of our inspection.

	Dampness, Rot and Infestation

Notes	There was no evidence found of significant dampness, rot or infestation within those areas of the property available for inspection.

	Chimney Stacks

Notes	The chimney stack is weathered consistent with its age. Ongoing maintenance will be required. It should be appreciated that flashing details require routine maintenance to ensure water tightness.



#### **Roofing including Roof Space**

Notes	The roof covering appears original and is weathered and moss covered. It is now of an age where ongoing and regular maintenance will be required and it would be prudent to seek the advice of a roofing contractor to comment on its current condition and expected lifespan.

Notes	At the time of our inspection there was no evidence of damp staining/water staining on wall surfaces which would indicate leakage. It should be noted that it was not raining at the time of our inspection.

	Main Walls

Notes	The main outer walls of the property appeared in fair order consistent with age.

	Windows, External Doors and Joinery
Repair Category	2
Notes	The windows are of an older style and type and, where tested, functioned adequately. Given their age, ongoing maintenance to opening mechanisms will be required to ensure they are in satisfactory working order. A unit at upper level is missing a window handle, although we understand this is to be repaired prior to sale.  Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/repair will be required as part of an ongoing maintenance programme.  Double glazed windows may be prone to misting/interstitial condensation which can be more evident and can change in certain temperatures/weather conditions.

Notes	The timber weatherboarding is in fair order. Regular repainting/treatment will be required if this is to be maintained in satisfactory condition.  PVC fascia/soffits require no decoration.

	Garages and Permanent Outbuildings
Repair Category	2
Notes	The garage appears in adequate condition for its age and usage. The manual up-and- over door was operational at the time of our inspection.
	The garage may contain asbestos material. The current informed view is that if left undisturbed this will present no significant hazard to health. However, in the event of damage or disturbance higher than average costs should be anticipated in respect of removal and handling.



#### **Outside Areas and Boundaries**

Notes	The garden grounds were found to be adequately maintained and boundaries were intact at the time of our inspection.  As stated, the site to the rear is sloping in nature. The retaining walls were noted to be under pressure and slight cracking has occurred. The paving slabs are affected by cracking and unevenness and future repair should be anticipated.

	The electric fire was not tested.

Notes	The electrical consumer unit has been upgraded in the past, although it is unclear the extent of upgrading works having been carried out to concealed wiring. As such, we recommend that the system be checked and upgraded as necessary by an NICEIC/SELECT registered electrical contractor.  The Institution of Engineering and Technology recommends that inspections and testing are undertaken at least every ten years and on a change of occupancy. It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.

Notes	In the interest of safety all gas appliances should be checked by a Gas Safe registered engineer.

	Water, Plumbing and Bathroom Fittings
Repair Category	1
Notes	The plumbing and fittings appear of copper/PVC piping where seen and appeared in serviceable condition but was not tested.
	The shower room fittings are along modern lines and we noted no significant defect from our visual inspection. Waterproof seals were generally intact at the time of our inspection. No high moisture levels or suspect flooring were noted to the limited accessible areas surrounding.
	It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Notes	The central heating system is assumed to have been suitably serviced throughout its history and a copy of relevant documentation in this regard should be obtained prior to purchase. This is assumed to be in order.

#### 4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

#### Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

The property has been extended in the past whereby the attic has been converted to form additional living accommodation. These works appear to have been carried out in excess of twenty years ago and are deemed to be historic. More recent alterations include the installation of bi-fold doors within the rear bedroom. It is assumed that any necessary and relevant consents and permissions were obtained for these works.

#### **Estimated Reinstatement Cost for Insurance Purposes**

£390,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £390,000 (THREE HUNDRED AND NINETY THOUSAND POUNDS STERLING).

#### **Valuation and Market Comments**

£265,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £265,000 (TWO HUNDRED AND SIXTY-FIVE THOUSAND POUNDS STERLING).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. \*

#### 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. 

The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

#### **DESCRIPTION OF THE REPORT**

#### 2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

#### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.





#### The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO<sub>2</sub> emissions, running costs and the savings possible from making improvements.

#### The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 40 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 4.2 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 0.7 tonnes per year. 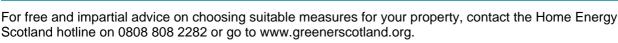

#### About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

#### 1 Loft insulation

Loft insulation laid in the loft space or between roof rafters to a depth of at least 270 mm will significantly reduce heat loss through the roof; this will improve levels of comfort, reduce energy use and lower fuel bills. Insulation should not be placed below any cold water storage tank, any such tank should also be insulated on its sides and top, and there should be boarding on battens over the insulation to provide safe access between the loft hatch and the cold water tank. The insulation can be installed by professional contractors but also by a capable DIY enthusiast. Loose granules may be used instead of insulation quilt; this form of loft insulation can be blown into place and can be useful where access is difficult. The loft space must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about loft insulation and details of local contractors can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk).

#### 2 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

#### 3 Low energy lighting

Replacement of traditional light bulbs with energy saving bulbs will reduce lighting costs over the lifetime of the bulb, and they last many times longer than ordinary light bulbs. Low energy lamps and fittings are now commonplace and readily available. Information on energy efficiency lighting can be found from a wide range of organisations, including the Energy Saving Trust (http://www.energysavingtrust.org.uk/home-energy-efficiency/lighting).

#### 4 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

#### Low and zero carbon energy sources

Low and zero carbon (LZC) energy sources are sources of energy that release either very little or no carbon dioxide into the atmosphere when they are used. Installing these sources may help reduce energy bills as well as cutting carbon.
